operation were still employed four years after the procedure. In comparison, only 68 percent and 44 percent of patients who were in the age range of 55 to 59 years or 60 years or more, respectively, at the time of the operation were employed four years after the operation.

Patients who were not working before the operation tended to remain unemployed following the operation. The factors that affected the decision not to work included the patient's age at the time of the operation, the development of angina pectoris after the operation, a previous myocardial infarction, and the physical requirements of the patient's prior employment. Of patients not employed prior to the operation, 22 percent were employed four years later.

## Health Care Delivery

Siegler M. *A Right to Health Care: Ambiguity, Professional Responsibility, and Patient Liberty*. *JOURNAL OF MEDICINE AND PHILOSOPHY* 4(2): 148-57 (June 1979) [7-614].

A social right to health care would change the physician-patient relationship from one of covenant into one of contract, because, both parties being partly coerced into the relationship, they would lack that element of mutual surrender or "donation" which supports a covenantal relationship. A right to health care would also restrict the liberty of citizens to engage in unhealthful behavior, because it would actually be understood as a right to health. Once health becomes a governmental guarantee, *i.e.*, a right, it will lead, as have other governmental guarantees, such as public education or safe air travel, to governmental prohibition of personal behaviors inimical to the attainment of the guaranteed outcome.
