FORECASTING

An Appraisal for Policy-Makers and Planners

William Ascher, foreword by Harold D. Lasswell

Forecasting plays a central role in American social and economic planning. Forecasts not only determine how billions of dollars will be spent but also commit national policies far into the future. Yet no one really knows how to judge the accuracy of forecasts, whether their accuracy is increasing, or how they are used in decision-making.

In this innovative study, William Ascher examines the records of expert forecasting of national trends in population, economics, energy, transportation, and technology over a fifty-year period. By examining forecast methods and sources, he identifies factors associated with greater accuracy as well as with systematic biases. He finds that the methodological sophistication of computer models, for example, is relatively unimportant compared to core assumptions concerning the broad context of a trend.

Several case studies also trace the impact of expert forecasting on governmental and private decision-making. The book can therefore serve as a guide for policy-makers in government and industry in interpreting and using expert forecasts available to them. It can also be used as a text for courses in public policy analysis.

CHINA-WATCH

Toward Sino-American Reconciliation

Robert G. Sutter, foreword by Allen S. Whiting

Encompassing all the major interactions of Sino-American relations, *China-Watch* views the Maoist leaders as students of balance-of-power politics. Thus, in the late 1960s, when Peking faced heavy pressure from Soviet power, the PRC leaders responded by formulating a new foreign policy emphasizing closer Sino-American relations. Changes in the East Asian balance of power in the 1940s and 1950s had also prompted the Chinese communists to soft-pedal ideological differences and seek closer ties with the United States but complications on the U.S. side precluded cooperation in these instances.

Robert G. Sutter mines the most relevant evidence from U.S. documentary sources and the Chinese media to give a fascinating and timely account of behind-the-scenes moves and motivations that will interest the general reader and specialist alike.

Ethnic Conflict in the Western World

Why, in the late 1960s, did ethnic minorities such as Scots and Welsh, Québécois, Bretons and Basques unexpectedly begin to protest and assert their demands with fresh vigour, confidence, and even violence? What are the factors that help to explain the activation of these ethnic political movements, some of which now threaten the continued integrity of such long-established states as Canada and Great Britain? The Gladstone Diaries

In the first years described in these volumes, Gladstone was in semi-retirement after resigning from Palmer's administration. In 1859, however, he returned to the Cabinet as Chancellor of the Exchequer, becoming, after the Tory Government of 1866–68, Prime Minister. The diary records the daily work of Gladstone's great period as a financial reformer, his consequent rows with Palmerston, his widening political horizons and ascendancy within the Liberal party, his changing views on parliamentary reform, and his change of constituency from Oxford University to the 'unmuzzled' possibilities of Lancashire and Greenwich.
