GUIDELINES FOR SUBMISSION OF MANUSCRIPTS

Completed manuscripts, inquiries about material for possible publication, and correspondence to the editor should be sent to the editorial offices of the *Journal of Asian Studies*:

Because of the multidisciplinary nature of our readership, articles in *JAS*, no matter how narrowly focused, should raise larger questions of interest outside the precise research specialties of their authors. Article manuscripts, including notes and references, should not exceed forty pages in length. Submit four copies of the manuscript if sending by post or attach Microsoft Word or .pdf files if submitted electronically. Please include a 150 word abstract. Do not include the author's name on the manuscript, as *JAS* engages in double-blind reviews. All submitted work should be **double-spaced**, including extracts, notes, and references. Notes should be as few as possible and appear at the end of the text. Documentation should follow the style recommended in sections 16.90 through 16.120 of the *Chicago Manual of Style*, 15th edition (Chicago: University of Chicago Press, 2003), pp. 616–24; Consult recent issues of *JAS* as a guide to format. Authors are encouraged to submit tables, figures, maps, photographs, and other illustrations along with their manuscripts; please consult the editor for further specifications. All manuscripts must use 12-point and left-justified type, with one-inch margins on letter size (8½ x 11 in.) paper. Language romanization should follow Library of Congress guidelines (Chinese: Pinyin, Japanese: Hepburn, Korean: McCune-Reischauer). For other romanization schemes, consult the table at <http://www.loc.gov/catdir/cpsd/roman.html>.

All manuscripts submitted to *JAS* are expected not to have been published elsewhere and not be under review for possible publication elsewhere. Unsolicited book reviews are not accepted.
