

## REVIEWS

*Automobile Insurance Rate Making* (380 pages. Casualty Actuarial Society, New York 1961; \$ 7.50).

Since the founding of the Casualty Actuarial Society in 1914, making rates for automobile insurance has been the subject of many papers which have appeared in the Proceedings of the Society. Some of these papers were transitory in nature while others set forth principles which are as timely now as they were when written. This volume, which runs to 380 pages, brings together, according to subject matter rather than in chronological sequence, those papers which best cover the many aspects of automobile insurance rate making in the United States of America. The book contains 24 papers or contributions and is divided into the following main sections:

Rating Systems and the Statistical Base  
Standard Rate Making Methods  
Private Passenger Merit Classification  
The Compulsory Approach  
Possible Improvements in Rate Making Procedures  
Credibility

The book contains a fund of information on every aspect of automobile insurance rate making and much valuable statistical data. The section on merit rating, a subject of special interest at the present time, runs to over 50 pages and provides the actuary with all the important facts, figures and formulae. The authors of the various papers, while all actuaries, have diverse employment—Managers of Bureaus, Actuaries of Stock and Mutual Companies, Government Officials—so that the book represents not a single view of rate making problems but the views of the whole actuarial profession.
