CONTRIBUTORS

Eric Mack is Associate Professor of Philosophy at Tulane University. His research interests involve topics in moral, political, and legal philosophy. Among his recent articles are: "In Defence of Blackmail," in *Philosophical Studies*; "The Moral Basis of National Defense," in *Defending a Free Society*, ed. R. Poole; "Deontology, Negative Causation and the Duty to Rescue," in Gewirth's *Ethical Rationalism*, ed. E. Regis; and "The Ethics of Taxation: Rights versus Public Goods?" forthcoming in *Taxation and Capital Formation*, ed. D. Lee.

Baruch A. Brody is the Leon Jaworski Professor of Biomedical Ethics at Baylor College of Medicine and Professor of Philosophy at Rice University. His most recent books include *Identity and Essence* (Princeton University Press: 1981) and *Ethics and Its Applications* (Harcourt Brace Jovanovich: 1983). He is currently working on a book entitled *Beyond Paternalism and Autonomy*.

Robert L. Pfaltzgraff, Jr., is Shelby Cullom Davis Professor of International Security Studies at the Fletcher School of Law and Diplomacy, Tufts University, and President of the Institute for Foreign Policy Analysis, Inc., Cambridge, MA., and Washington, DC. His most recent publications include *International Security Dimensions of Space* (1983), and *National Security: The Decision-Making Process* (1984).

Steven J. Brams is Professor of Politics at New York University. His recent books include *Superpower Games: Applying Game Theory to Superpower Conflict* (1985), *Superior Beings: If They Exist, How Would we Know? Game-Theoretic Implications of Omniscience, Omnipotence, Immortality, and Incomprehensibility* (1983), and, with Peter C. Fishburn, *Approval Voting* (1983).

D. Marc Kilgour is Associate Professor of Mathematics and Chairman of the Department of Mathematics at Wilfrid Laurier University (Canada). His research interests include mathematical modeling, especially using game theory, and his recent articles have appeared in *Canadian Journal of Political Science*, *Public Choice*, and *Theory and Decision*. Research on his

article with Steven J. Brams in this volume was done while he was Visiting Associate Professor in the Department of Systems Design, University of Waterloo, during 1984–85.

David Hoekema is the Executive Secretary of the American Philosophical Association and Assistant Professor of Philosophy at the University of Maryland. His publications in this area include “Intentions, Threats and Nuclear Deterrence” in *The Applied Turn in Contemporary Philosophy* (Bowling Green State University 1983).

Steven Lee is an Associate Professor of Philosophy at Hobart and William Smith Colleges. He is co-editor (with Avner Cohen) of *Nuclear Weapons and the Future of Humanity: The Fundamental Questions* (Totowa, NJ: Rowman and Allanheld, 1985) and author of “The Morality of Nuclear Deterrence: Hostage Holding and Consequences” in *Ethics* 95. In addition, he has published in the areas of philosophy of law, social philosophy, and action theory.

Henry Shue is Senior Research Associate at the Center for Philosophy and Public Policy at the University of Maryland at College Park where he is the principal investigator examining the moral aspects of three proposed departures from the continuing counterforce buildup: the defensive transition, finite deterrence, and prompt rejection of nuclear forces. He is in the early stages of a monograph with the working title, *The World's Last Night*. Best known for his defense of core economic rights in *Basic Rights: Subsistence, Affluence, and U.S. Foreign Policy* (Princeton, 1980), he has recently published articles including “The Burdens of Justice” and “Subsistence Rights.”

Douglas P. Lackey was a student of J. N. Findly at Yale and is currently Professor of Philosophy at Baruch College and the Graduate Center, City University of New York. His publication in this area include the articles, “Ethics and Nuclear Deterrence” (1975), “Missiles and Morals” (1982), and “Disarmament Revisited” (1983). His book, *Moral Principles and Nuclear Weapons* was published by Rowman and Allanheld in 1984.

Aaron Wildavsky is Professor of Political Science and Public Policy at the University of California, Berkeley. He is the author of *The Nursing Father: Moses as a Political Leader* and (with Mary Douglas) *Risk and Culture*. He has edited and contributed to *Beyond Containment: Alternative American Policies Toward the Soviet Union*.

Paul Seabury is currently Professor of Political Science, University of California, Berkeley, specializing in U.S. foreign policy problems. He is co-author, with Professor Walter McDugal, of the *Grenada Papers* published by the Institute for Contemporary Studies in 1984.

Eliot A. Cohen is an Assistant Professor of Government at Harvard University, from which he received his B.A. and Ph.D. degrees. Next year he will be a Visiting Associate Professor of Strategy at the U.S. Naval War College in Newport, Rhode Island. His most recent book is *Citizens and Soldiers: The Dilemmas of Military Service* (Ithica: Cornell University Press, 1985), and he has published numerous articles on defense issues in *inter alia*, *International Security*, *Foreign Affairs*, *Commentary*, and *The Public Interest*.
