1976-77 Public Administration Fellows Program

Applications are now being accepted for the 1976-77 Public Administration Fellows Program of the National Association of Schools of Public Affairs and Administration. The program, sponsored jointly by the U.S. Civil Service Commission and NASPAA, provides one-year policy-level positions in the Executive Branch of the federal government for college and university professors teaching at NASPAA member institutions.

Program fellows provide staff support to responsible executives in federal administrative agencies. Work assignments and functions involved concern with administrative systems and process, budgeting, personnel management, policy development, and program planning and evaluation. Compensation for each fellow is determined according to experience and educational background and generally ranges from GS-12 to GS-15. Appointments are usually for a period of one year, generally beginning in early September. Positions are located in the Washington, D.C. metropolitan area and at federal regional office locations. Federal agencies are encouraged to use the Intergovernmental Personnel Act (IPA) mobility authority to assign fellows.

Full-time public administration faculty are eligible to participate. Applicants must meet the following requirements.

- Hold a teaching position at a NASPAA member institution.
- Have a teaching focus in public affairs/public administration.
- Have significant teaching experience in public affairs/public administration.
- Have limited or no work experience in governmental agencies (federal, state, local).
- Provide an indication of how governmental work experience will benefit the applicant and the applicant's academic institution.
- Have a long-term commitment to teaching and the full expectation of returning to teaching after the PA Fellowship.
- Show evidence of support from the applicant's academic institution (indicated by a supporting letter by the applicant's chairman, dean, etc.)
- Hold the doctoral degree at the time of application.

The college or university from which a Public Administration Fellow comes will be required to remit to NASPAA a participation fee of \$250 for each fellow selected from the institution. Each federal agency hiring a Public Administration Fellow is required to remit a fee of \$750 for each fellow placed in the agency. The funds will be used to pay for the expenses involved in the administration of the program,

including recruitment, selection, placement, and professional development.

The deadline for filing a completed application with NASPAA for the 1976-77 program is November 1, 1975. Announcement of Awards

ACE Academic Administration Fellows

The American Council on Education, the nation's major coordinating body for postsecondary education, has announced the selection of 45 Fellows in Academic Administration for the 1975-76 academic year. The Fellows will participate in the Academic Administration Internship Program which provides an opportunity for faculty and junior staff to prepare for careers in higher education administration through seminars and a nine-month internship experience under the guidance of senior administrators nationwide.

Among the ACE Fellows are three political scientists: Richard J. Daleski, The National War College; Grant T. Hammond, Lenoir Rhyne College; and James E. Harf, Ohio State University.

U.S. Office of Education Public Service Education Grants

Institutional grants and fellowships totaling \$4.0 million have been awarded to institutions of higher education by the U.S. Office of Education to support public service education during the 1975-76 academic year. This program, enacted under Parts A and C of Title IX of the Higher Education Act of 1965 as amended, was authorized to award both institutional grants to establish or improve graduate public service programs and fellowships for graduate study to students who plan public service careers. In this context, "public service education" is defined as the preparation of persons for leadership and management at all levels of government and in non-profit community service agencies.

Last May a total of 285 program applications were received from 160 institutions requesting over \$17.0 million. In addition to a staff review, all applications were thoroughly and carefully evaluated on a competitive basis by teams of outside readers who were selected for this responsibility because of their knowledge about and experience in the field of public service education. Of the total funding, \$2.3 million in institutional grants was awarded to 58 colleges and universities, while \$1.7 million

of fellowship aid was awarded to 52 institutions to support 263 students.

The institutional grant may be used for the following purposes: to strengthen the faculty; to expand programs of study; to improve program administration; to develop or carry out cooperative arrangements with graduate and professional schools; and to purchase or rent instructional equipment and materials. The institutional grant may not be used for payment in excess of 66-2/3 percent of the total cost of the project or activity.

Students selected to participate in the fellowship program receive a stipend of \$3,000 for the year with a \$500 allowance for each eligible dependent. In addition, the educational institution receives an allowance of \$3,000 for each fellowship to cover the cost of any tuition or

nonrefundable fees that may be charged to the Fellow.

Although all fellowships have been awarded for the next academic year, persons interested in applying for any future fellowships should apply directly to a college or university which has an approved program. To be eligible, a student must be acceptable for full-time graduate degree study in an approved program, be interested in a professional career in public service, and be a citizen or National of the U.S. or have permanent immigration status.

The Public Service Education is administered by the Division of Training and Facilities of the Bureau of Postsecondary Education. The Program Manager is Dr. Louis J. Venuto.
