Brooke Ackerly is Associate Professor of Political Science at Vanderbilt University. She studies democratic theory, feminist methodologies, human rights, social and environmental justice. She integrates empirical research on activism into her theoretical work. Her publications include *Political Theory and Feminist Social Criticism* (2000) and *Universal Human Rights in a World of Difference* (2008). In collaboration with Jacqui True she is working on a text on feminist research methodologies, *Doing Feminist Research in Social and Political Sciences*.

Clair Apodaca is an Associate Professor in the Department of Politics and International Relations at Florida International University. Dr. Apodaca has published extensively in the areas of the international protection of human rights, women's human rights, and refugee studies. She is currently completing a book, *Child Hunger and Human Rights: International Governance* (Routledge 2010). Her work has appeared in the *Journal of Human Rights*, *International Studies Quarterly*, and *Human Rights Quarterly*, among many others.

Mary Caprioli is Associate Professor at the University of Minnesota-Duluth. She serves on the WomanStats Board of Directors. Her current main research interests include linking the security of women to the security of states. Her recent articles have appeared in *International Security* and *Foreign Policy Analysis*.

Suzanne Dovi is an Associate Professor of Political Science and Philosophy at the University of Arizona. Her research interests include democratic theory, representation (especially the representation of historically disadvantaged groups), feminist theory and normative concepts like hypocrisy and despair. Her work has appeared in *American Political Science Review*, *Journal of Politics*, and *Polity*. Her book, entitled *The Good Representative*, was published in 2007 by Blackwell.

Kim Fridkin is Professor of Political Science at Arizona State University. She is the author of *The Political Consequences of Being a Woman*

(Columbia University Press, 1996) and the co-author of *The Spectacle of U.S. Senate Campaigns* (Princeton University Press, 1999) and *No-Holds Barred: Negative Campaigning in U.S. Senator Campaigns* (Prentice Hall, 2004). She has contributed articles to various academic journals including the *American Political Science Review*, *American Journal of Political Science*, and the *Journal of Politics*.

Elisabeth Jay Friedman is Associate Professor of Politics and Chair of Latin American Studies at the University of San Francisco. She is author of *Unfinished Transitions: Women and the Gendered Development of Democracy in Venezuela, 1936–1996* (Penn State Press, 2000), and *Sovereignty, Democracy, and Global Civil Society: State-Society Relations at UN World Conferences* (with Kathryn Hochstetler and Ann Marie Clark, SUNY Press, 2005). She has also published articles on women's organizing in Latin America and globally. Her current research focuses on the transnational diffusion of gender-based and sexual rights.

G. Claire Haeg is Assistant Professor of Political Science at the College of St. Benedict and St. John's University in Minnesota. She teaches and studies political institutions, and her previous scholarship includes a comparative study of neo-populist political parties in advanced industrial democracies. Her current research project is an examination of the pre-political careers of women legislators in the United States Congress.

Magda Hinojosa is Assistant Professor of Political Science at Arizona State University. Her research focuses on institutional obstacles to women's political representation in Latin America. Her work on women in Mexican politics appeared in *Women and Legislative Representation: Electoral Systems, Political Parties, and Sex Quotas* (Palgrave Macmillan, 2008), edited by Manon Tremblay. She is working on a manuscript that assesses the effects of party recruitment and selection procedures on women's political representation across Latin America.

Patrick J. Kenney is Chair and Professor of Political Science at Arizona State University. Professor Kenney has authored and co-authored articles in the *American Political Science Review*, *American Journal of Political Science*, *Political Behavior*, and the *Journal of Politics*. He has co-authored two books with Kim Fridkin, *The Spectacle of U.S. Senate Campaigns* (Princeton Press, 1999) and *No-Holds Barred: Negativity in*

U.S. Senate Campaigns (Prentice Hall, 2004). His research areas are in campaigns, elections, and voting behavior.

Celeste Montoya is Assistant Professor in the Women and Gender Studies Program at the University of Colorado, Boulder. Her broader research agenda addresses the political participation and mobilization of marginalized groups. Her current research focuses primarily on international organizations, transnational activism, and domestic policy aimed at combating violence against women, in particular, European initiatives. Her work has been published in *International Organization*, *Urban Affairs Review*, and *Social Science Quarterly*.

Laura Parisi is Assistant Professor in the Department of Women's Studies at the University of Victoria, Victoria, British Columbia, Canada. Dr. Parisi has published in the areas of gender and human rights, development and globalization. Her forthcoming publications include chapters on these topics in *Beyond Gender and Global Restructuring*, edited by Marianne H. Marchand and Anne Sisson Runyan (Routledge), and in the *International Studies Association Compendium Project*, edited by Robert A. Denmark et al. (Wiley-Blackwell).

Anne Sisson Runyan is Professor and Head of the Department of Women's, Gender, and Sexuality Studies at the University of Cincinnati. A Ph.D. in International Relations, she has published widely in the field of feminist world politics that she helped pioneer and for which she received the Distinguished Scholar Award from the Feminist Theory and Gender Studies section of the International Studies Association. Among her publications include *Global Gender Issues* (new third edition now available) and *Gender and Global Restructuring* (second edition in progress).

James Lance Taylor is Associate Professor of Politics at the University of San Francisco, and author of the forthcoming book, *Sons of Thunder: Malcolm X, Louis Farrakhan and the Haunting of America* (Lynne Rienner).

This volume argues that international human rights law has made a positive contribution to the realization of human rights in much of the world. Although governments sometimes ratify human rights treaties, gambling that they will experience little pressure to comply with them, this is not typically the case. Focusing on rights stakeholders rather than the United Nations or state pressure, Beth Simmons demonstrates through a combination of statistical analyses and case studies that the ratification of treaties leads to better rights practices on average. By several measures, civil and political rights, women's rights, a right not to be tortured in government detention, and children's rights improve, especially in the very large heterogeneous set of countries that are neither stable autocracies nor stable democracies.

Why is national identity such a potent force in people's lives? And, is the force positive or negative? In this thoughtful and provocative book, Elizabeth Theiss-Morse develops a social theory of national identity and uses a national survey, focus groups, and experiments to answer these important questions in the American context. Her results show that the combination of group commitment and the setting of exclusive boundaries on the national group affects how people behave toward their fellow Americans. Strong identifiers care a great deal about their national group. They want to help and to be loyal to their fellow Americans. By limiting who counts as an American, though, these strong identifiers place serious limits on who benefits from their pro-group behavior. Help and loyalty are offered only to "true Americans," not Americans who do not count and who are pushed to the periphery of the national group.

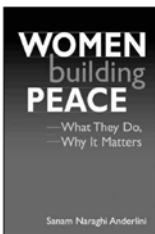

MANUSCRIPT PREPARATION

- Manuscripts must be no longer than 30 pages including text, tables and figures, references and appendices. The entire manuscript (including notes and references) must be double-spaced, with one-inch margins and 12-point font, and printed on one side of the page only.
- The author must include a separate title page, with his or her full contact information (including email address, telephone number and institutional affiliation), and a brief biographical statement. All identifying information must be removed from the manuscript.
- A second page must include an abstract of no more than 200 words.
- Placement of tables or figures should be cited in the text. The publisher will be responsible for placing artwork, tables or figures, as well as converting endnotes to footnotes.
- Appendices, tables, and figures should be numbered consecutively throughout the article and be included on separate pages

appearing after the reference section. Figures should be ready for photographic reproduction; they cannot be redrawn by the publisher. Charts, graphs, or other artwork should be professional rendered or computer generated. Photographs should be clearly printed and should remain legible after a 50% reduction.

- References and notes should conform to the APSA Style Manual. Authors should include full volume, issue, and page numbers for references. Author’s acknowledgments or other personal notes will appear as an unnumbered note at the foot of the page. Notes should be numbered consecutively throughout the article. Numbered notes should appear at the end of the sentence. If multiple texts are cited in a sentence they should appear as one consolidated note at the end of the sentence.
- Endnotes should be employed (rather than footnotes).
- All figure captions should be typed on a separate page (or pages), rather than on the figures themselves (which are camera-ready art) so that they can be copyedited.

Originality and copyright: Papers with multiple authors are reviewed with the assumption that all authors concur with its submission. A Copyright Transfer Agreement, with certain specified rights reserved by the author, must be signed and returned to the Editor by senior authors of accepted manuscripts, prior to publication. *Politics & Gender* does not accept manuscripts for review that are under review elsewhere, previously published or already committed for publication.

For general guidelines for preparing a manuscript for submission, please refer to the *APSA Style Manual for Political Science* (rev. ed. 2001) for citation, footnotes, references, and other style issues. Please note, in particular, the statement on gender-specific language (15).
