THE JOHNS HOPKINS STUDIES IN NINETEENTH-CENTURY ARCHITECTURE

Nineteenth-century architecture is important not only as a reflection of its own age but as an influence on later architecture and architectural principles. During the nineteenth century American architects in particular began to emerge as individuals within a distinct and developing tradition. Despite its importance and influence, however, the architecture of the period has received scant interpretive and analytical treatment by scholars and theorists of the twentieth century.

The Johns Hopkins Studies in Nineteenth-Century Architecture has been instituted to fill this gap. Each year one or two books will be published in the series, primarily in three areas of British and American architecture: critical biographies of important architects, studies of themes and trends in architecture, and collections of essays on architecture and architects.

The first in the series is described on this page. Phoebe B. Stanton, the author of this first volume, is also general editor of the series.

THE GOTHIC REVIVAL AND AMERICAN CHURCH ARCHITECTURE

An Episode in Taste, 1840-1856

BY PHOEBE B. STANTON

Focusing on the mid-nineteenth century, Professor Stanton here explores the influence of the English ecclesiological Gothic revival on American church architecture. Largely a product of English taste, this fundamentally conservative movement was to provide a foundation for a new aesthetic in American architecture.

Turning first to the theoretical expression of English revivalism in the writings of the movement's leading proponents and to the buildings themselves, Professor Stanton surveys the architectural principles and models most influential in America. She concentrates on the development of American excellence, exploring fully the influence of the earliest English Gothic churches and progressing through a large sampling of their American counterparts. Throughout, the author maintains an emphasis on both theoretical and practical considerations, tracing the development of American style and theory in terms of the work and writings of individual architects and of their major organization, the New York Ecclesiology Society.


