SOVEREIGNTY AND SOCIETY IN COLONIAL BRAZIL

The High Court of Bahia and Its Judges, 1609–1751

In this fascinating study Stuart Schwartz presents a detailed analysis of the judicial bureaucracy and the techniques used by the Brazilian elite to maintain their colonial dominance.

Presided over by the governor-general or viceroy, the High Court stood at the apex of the colonial administrative structure and symbolized royal sovereignty.

In colonial Brazil sugar was the principal basis of wealth. Mr. Eisenberg offers the first detailed study in English of the causes of the decline and of the responses of the planters and government. He disputes the findings of other historians who have tended to romanticize slavery and to underplay the extent of the decline of the industry; despite modernization, according to the author, both slaves and freeworkers were exploited by planters. Their miseries, and the condition of the industry, were only made worse by the actions of the government.
