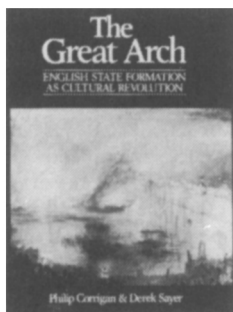

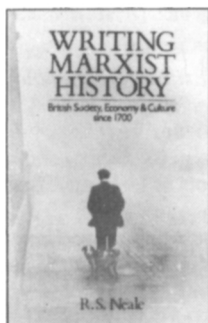

THE ORIENTAL QUESTION, 1840–1900

Files from the Royal Archives, Windsor Castle

The history of British foreign relations in the nineteenth century is a record of shifting policies, strategies, and alignments. The years 1840–1900 were especially marked by changes in Britain's response to the new political realities shaping modern Europe. One issue of great importance for the direction of British policy in these years was the Eastern Question—the problems brought about by the decline of the Ottoman Empire and the future of the European balance of power.

The significance of the Eastern Question (or, as it is called in the Royal Archives, the Oriental Question) is clearly seen in the correspondence, memoranda, and policy analyses found in the Royal Archives. University Publications of America has now been granted permission to make available for the first time the complete series of files on this subject. These include Queen Victoria's correspondence with her ministers, the principal papers of state forwarded to the Queen for her consideration, and her correspondence with other European sovereigns and members of their families. Numbering nearly 40,000 manuscript pages—reproduced in their entirety—these records offer an unusually intimate look at British diplomatic history.

The following topics are among the major ones covered in this collection: the Turco-Egyptian War, the Straits Convention, the Holy Places issue, Palmerstonian politics, the Vienna Note, the Crimean War, the question of the Balkan Principalities, the Hatt-I Humayun (Christian Reform Edict), the Bulgarian atrocities, interest in the Suez Canal, the Crete insurrection, the Constantinople Conference, the Russo-Turkish War, the Treaty of San Stephano, the Congress of Berlin, division of the Balkans into independent states and spheres of influence, the Syrian expedition, and the First and Second Mediterranean Agreements.

This material is indispensable for scholars and students who are interested not only in the Eastern Question but also in the major trends in British foreign policy in the nineteenth century.

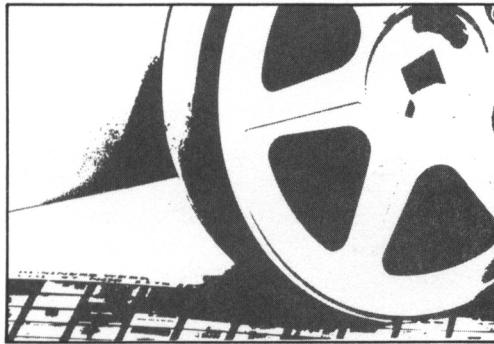
Wallington's World A Puritan Artisan in Seventeenth-Century London
