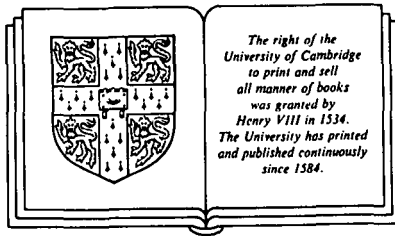

This set of books on Africa was written specifically for use in a one-year general African History course. Volume 1 traces African history from the earliest man-apes to the beginning of the nineteenth century. Encompassed in this period are such broad subjects as the Neolithic revolution, Bantu migrations, Sudanic states, the rise of Islam, the beginnings of European imperialism, and the slave trade. Volume 2 continues this survey of sub-Saharan Africa from 1800 through 1979. Major topics covered in some detail are European imperialism and the scramble for Africa, European systems of rule, African nationalism the drive for independence, and the post-independence period. This third volume relates the nationalistic drive for an end to European political imperialism and the subsequent difficult years of independence.

CONTRIBUTIONS

Contributions to the *Journal* are welcomed. They may be submitted in either English or French. They should not exceed about 6000 words (excluding footnotes), except with the prior approval of the Editors. A summary of the contents of the article, not exceeding about 300 words in length, should be attached on a separate sheet. Contributors are asked to observe closely the conventions listed in the Notes for Contributors, Vol. XV, pp. 173–4. It is essential that contributors observe these conventions, which may be had on request from the Editors, as the *Journal* now goes straight into page proof. This severely limits the number of corrections which are possible.

Page proofs will be sent, if necessary by airmail, to each contributor (or his nominee) provided that the Editors have been given an address through which he can be reached without delay. Corrections should be kept to the minimum, and should be corrections, not new material. If they are to be incorporated in the master proof corrected by the Editors, it is important that the contributor should return the page proofs, by airmail if necessary, to the Editor named when they are sent out (and *not* to the Cambridge University Press), within ten days of his receipt of them.

Contributors of articles and review articles receive 25 free offprints. Additional offprints may be obtained at reasonable cost, provided that they are ordered before publication on the special form sent out with the page proofs.
