2001-2002 Fellowships

The Library Company of Philadelphia's Program in Early American Economy and Society will award one dissertation fellowship and one advanced research fellowship, tenable for nine consecutive months from September 2001 to May 2002 and carrying stipends of \$15,000 and \$30,000, respectively. The Program will also award four one-month research fellowships carrying stipends of \$1,500, tenable from June 2001 to May 2002.

Designed to promote scholarship on the origins and development of early American business and the economy to roughly 1850, these fellowships will provide scholars the opportunity to use the extensive printed and manuscript collections related to the history of commerce, finance, technology, manufacturing, agriculture, internal improvements, and economic policy-making that are held by the Library Company and by numerous other institutions in its vicinity.

APPLICATION DEADLINE IS MARCH 1, 2001, with a decision to be made by April 15. To apply, send four copies each of a c.v., a detailed description of the nature of the research to be undertaken during the fellowship period, a relevant writing sample of no more than 25 pages, and two letters of recommendation sent by separate mail to: The Library Company of Philadelphia, Program in Early American Economy and Society, 1314 Locust Street, Philadelphia, PA 19107. U.S. Bank Deregulation in Historical Perspective

Charles W. Calomiris

This book shows how deregulation is transforming the size, structure, and geographic range of U.S. banks, the scope of banking services, and the nature of bank-customer relationships. Over the past two decades the characteristics that had made American banks different from other banks throughout the world—a fragmented geographical structure of the industry, which restricted the scale of banks and their ability to compete with one another, and strict limits on the kinds of products and services commercial banks could offer—virtually have been eliminated. Understanding the origins and persistence of the unique banking regulations that defined U.S. banking for over a century lends an important perspective on the economic and political causes and consequences of the current process of deregulation.

Violent Disputes over Property Rights in 18th-Century China

Thomas M. Buoye

Thomas Buoye examines the impact of large-scale economic change on social conflict in eighteenth-century China. He draws on a large number of documented cases of violent property disputes to recreate the social tensions fostered by the development of property rights, an unprecedented growing population, and the increasing strain on land and resources. This book challenges the “markets” and “moral economy” theories of economic behavior. Applying the theories of Douglass North for the first time to this subject, Buoye uses an institutional framework to understand seemingly irrational economic choices.

The Market Economy and Christian Ethics

Peter H. Sedgwick

In this book Peter Sedgwick explores the relation of a theology of justice to that of human identity in the context of the market economy. He focuses on three main themes: how the market economy shapes personal identity, through consumption and the experience of paid employment in relation to the work ethic; the impact of the global economy on local cultures; and the effects of technology and global competition on poverty. Sedgwick recommends that the churches remain part of the debate in reforming and humanizing the market economy.
