His idealized British society was more democratic than aristocratic, and he saw British politics as living proof that the ancients were wrong in their assumption that republics could not exist outside the confines of the city state.

Students of medieval thought have long been stimulated by the work of Ernest A. Moody. That intellectual debt should be increased by this volume, which brings together the significant studies and essays he wrote in the period 1933-1969. An initial long study, on William of Auvergne and his treatise *De anima*, has not hitherto appeared in print. Five of the essays deal with late medieval physics and its relation to the mechanics of Galileo; others bear on medieval logic and philosophy of language; and several are concerned with the historical and philosophical significance of Ockham, Burdian, and the *via moderna* of the fourteenth century. In his Introduction Professor Moody discusses the development of his interests in medieval thought and offers some critical reflection on the essays.

## TELEOLOGICAL EXPLANATIONS An Etiological Analysis of Goals and Functions

Larry Wright

The questions of "purpose" and "goal directedness" rank among the oldest problems in philosophy. No satisfactory solution has been found for them to date, although their basic importance is exemplified by the teleological concerns of the philosophy of biology which asks such questions as: 1) By what criteria do we identify purposive activity? 2) What kinds of systems exhibit purposive activity? 3) Does such activity require patterns of description and explanation that are not needed in accounts of non-purposive activity? 4) By what criteria do we identify functions? 5) What kinds of systems exhibit functional activity? 6) Does the description of functions require special patterns of analysis? Implicit in the above questions is the distinction between purposive and functional activity which, in some cases, may be mutually independent: there may exist some purposive activity that performs no function; some functions may be performed without purpose. Professor Wright thoroughly canvasses these and related problems, including the case against teleology, the characteristics of directed behavior, the several categories of functions, and the nature of action.

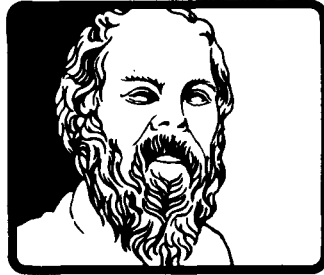
