The Mathematical Papers of Isaac Newton

Volume IV: 1674-84

Edited by **D. T. WHITESIDE**

This volume reproduces the texts of a number of minor papers, most of them never published before, on researches in algebra, number theory and trigonometry, pure and analytical geometry, the 'Geometria Curvilinea' and the 'Matheseos Universalis Specimina'. Newton's life between 1674-84 has previously been regarded as mathematically barren, except for his Lucasian lectures on algebra.

From 1677 onwards Newton was almost totally isolated from his contemporaries, and details of his personal life are sparse. What little is known is summarised in a general introduction, and a concluding appendix surveys highlights in his mathematical correspondence during 1674-76 with John Collins, Michael Dary, John Smith and especially Leibniz.
