THE ORIGINS OF FUNDAMENTALISM

Toward an Historical Understanding

by Ernest R. Sandeen

Traditionally historians have treated Fundamentalism as a predominately Southern populist phenomenon and as a cloak to hide socio-economic or psychological nakedness. Professor Sandeen's thesis is that this approach is in error, that there were theological affirmations and a common fight against "modernism" which forged an alliance between dispensationalism (Plymouth Brethren) and "Princeton theology" (an infallible Bible) and made Fundamentalism a discernible and significant force in American life.

THE AMERICAN RELIGIOUS DEPRESSION 1925-1935

by Robert T. Handy

Handy advances and documents the thesis that a religious depression occurred in American Protestantism during the decade 1925-1935. While he recognizes that there was some relationship between this depression and that which followed the stock market crash of 1929, a distinction can be made between the two. As a result of this depression the way was opened for the renewal of Protestantism in the next decades through a repudiation of its identification with American culture and a fresh quest for new and deeper understanding of its heritage.

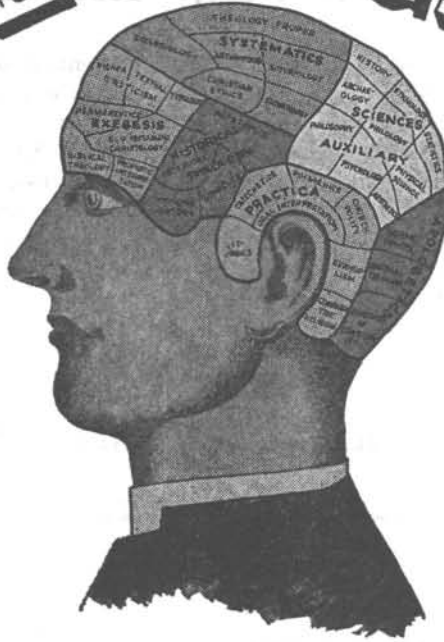
