## WHO'S SHAPING INTERNATIONAL LAW AT STANFORD?

**JENNY S. MARTINEZ:** made the first major attempt to analyze the ramifications of the increasing number of international tribunals operating in a globalized environment and argued the 2004 case of *Rumsfeld v. Padilla* before the U.S. Supreme Court

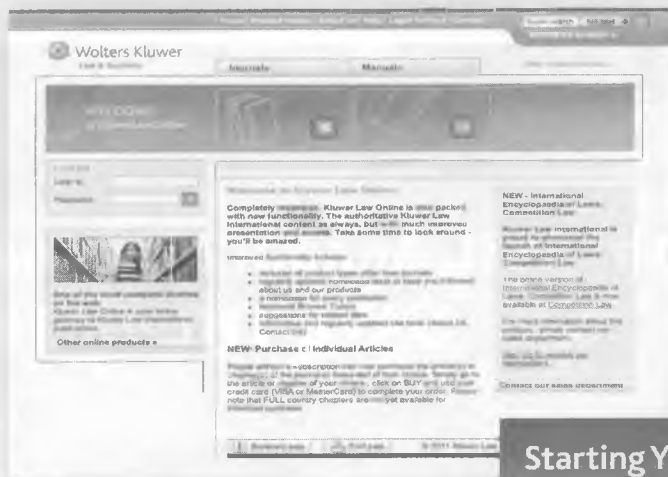
