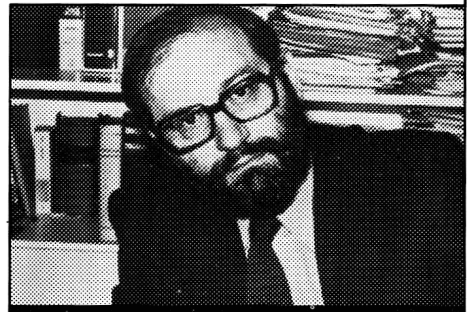


Umberto Eco

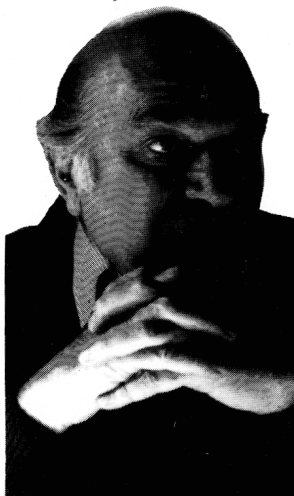

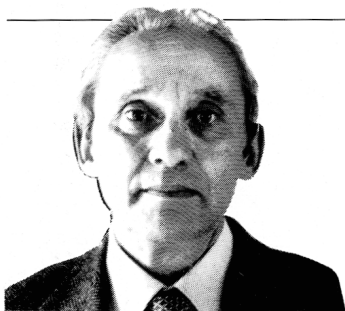

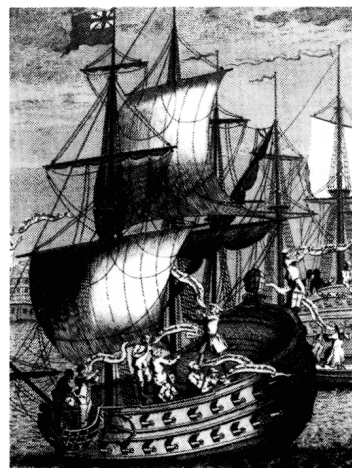
