The Contributors

Karl A. Wittfogel is Professor in the Far Eastern Institute, University of Washington, and Director of its Chinese History Project. He has written extensively on Chinese history, Oriental society, and problems of comparative institutional research and is co-author of *History of Chinese Society, Liao*.

Quincy Wright is Professor of International Law at the University of Chicago and a member of the editorial board of *World Politics*. He was director of the Causes of War Study at the University of Chicago and the author of *A Study of War*.

Seymour J. Rubin is a practicing attorney in Washington, D. C. He was formerly Assistant Legal Adviser in charge of economic affairs in the Department of State and has been a member of the United States delegations to the Mexico City, Potsdam, and Havana conferences.

Ivo Duchacek is Visiting Lecturer in Political Science at Yale University. In 1945 he was liaison officer between General Patton's army and the Czech Government, and from liberation in 1945 until the coup in 1948 he was chairman of the Foreign Relations Committee of the Czechoslovak Parliament.

Edward L. Katzenbach, Jr. is Instructor at Princeton University and is at present working on a "Political History of the French Army since 1789."

Nathan Leites is Visiting Lecturer in Political Science at Yale University and is on the staff of the Rand Corporation. He is at present specializing in the study of Bolshevism.

Jerome S. Bruner is Associate Professor of Social Psychology at Harvard University. He is currently at work on a book entitled "Men and Nations: A Psychological Approach to Foreign Policy."

George Peter Murdock is Professor of Anthropology at Yale University. In World War II he served as a Navy military government officer on Okinawa. His publications include *Our Primitive Contemporaries* and *Social Structure*.
