This sixth volume of *Early Music History* continues the traditions established by its predecessors. The contents cover a wide chronological range stretching from the early medieval period to the late sixteenth century. Two articles are concerned with aspects of chant traditions; one is a provocative discussion of the old question of the origins of Christian psalmody in the ancient synagogue, the other presents a detailed examination of the Gregorian eighth mode tracts in Old Roman transmission in an attempt to show how melodic form is determined by the accentuation, phrasing, and syntax of the text. Fifteenth-century studies are represented by a further contribution to the debate about the origins of two of the Trent codices, based on fresh paleographical evidence. Other articles present studies of an important early sixteenth-century Florentine chansonnier; conflicting attributions in some sixteenth-century printed books which argues that the conflict is the product of printing-house errors, and of the importance of contemporary rhetorical theory for an understanding of attitudes to music in the Seville of Morales and Bermudo. The reviews section includes consideration of two major books dealing with the histories of music in Bruges and Ferrara respectively, an important edition of a major late-fifteenth century songbook, a major study of the early viol, and a new edition of the Chester Mystery Cycle which includes discussion of its music. *Early Music History* is illustrated and includes music examples.
