## THE CONTRIBUTORS

BARRINGTON MOORE, JR., is a Senior Research Fellow at Harvard's Russian Research Center and Lecturer in the Department of Social Relations. At present he is making a comparative study of the political consequences of industrialism. His most recent book is *Terror and Progress USSR* (1954).

ADAM B. ULAM is Associate Professor of Government at Harvard University and Research Associate at the Russian Research Center. The author of *Philosophical Foundations of English Socialism* (1951) and *Titoism and the Cominform* (1952), he is one of the contributors to *Continuity and Change in Russian and Soviet Thought*, which will appear in November 1955.

GEORGE H. HILDEBRAND is Professor of Economics and Research Associate of the Institute of Industrial Relations at the University of California, Los Angeles. In collaboration with Wytze Gorter, he has completed a two-volume study, *The Pacific Coast Maritime Shipping Industry, 1930-1948* (Vol. I, 1952; Vol. II, 1954), and is now writing a book on wages and unemployment in postwar Italy.

STEPHAN BERNARD is a member of the Institut de Sociologie Solvay at the Free University of Brussels. Readers will recall an article of his, entitled "Choice in the West," which appeared in the January 1953 issue of *World Politics*.

EVERETT D. HAWKINS is Chairman of the Department of Economics and Sociology at Mount Holyoke College. He served with the ECA, MSA, TCA, and FOA as Program Planning Officer in Djakarta in 1951-1952 and as Desk Officer for Indonesia in Washington in 1952-1953. He is currently working as a special consultant to the Division of International Health of the Public Health Service on a report entitled "The Relation of Public Health to Economic Development in Underdeveloped Countries."

CLYDE KLUCKHOHN, Professor of Anthropology at Harvard University, served as director of the Russian Research Center from 1947 to 1954. In 1954-1955, he held a fellowship at the Center for Advanced Study in the Behavioral Sciences at Stanford, Calif. Among his publications are *Navaho Witchcraft* (1944), *Mirror for Man* (1949), and, with A. L. Kroeber, *Culture* (1952).

WILLIAM H. McNEILL is Associate Professor of History at the University of Chicago. His published works include *History Handbook of Western Civilization* (1949; new ed., 1954), *America, Britain and Russia: Their Cooperation and Conflict, 1941-1946* (1954), and *Past and Future* (1954). He is presently engaged in writing a major study, to be called *The Rise of the West*.

BENJAMIN I. SCHWARTZ is Assistant Professor of Far Eastern History and Government at Harvard University and Research Associate at the Russian Research Center. He is the author of *Chinese Communism and the Rise of Mao* (1951) and co-author, with Conrad Brandt and John K. Fairbank, of *A Documentary History of Chinese Communism* (1952).

RICHARD W. HATCH is Research Associate at the Center for International Studies, Massachusetts Institute of Technology. He collaborated with W. W. Rostow, Frank A. Kierman, Jr., and Alexander Eckstein on *The Prospects for Communist China* (1954), and with W. W. Rostow on *An American Policy in Asia* (1955).
