It is preferred that manuscripts be typed double-spaced, including quotes and footnotes. In general, the *Canadian Journal of Philosophy* follows *The University of Chicago Manual of Style*. Footnotes should be numbered consecutively and assembled on separate pages at the end of the manuscript. Manuscripts will not be returned unless return postage is prepaid by cheque, money-order, reply coupons, or Canadian stamps.

Authors will receive, without charge, 25 copies of their articles. Additional offprints may be ordered when the proofs are returned to the publisher.
