

ABOUT THE AUTHORS

RONALD J. BERGER is Associate Professor of Sociology at the University of Wisconsin–Whitewater. His recent and forthcoming publications focus on sexual assault, crime prevention, pornography, and comparative criminology. He is continuing his research on rape law reform and on crime and cross-national development.

PENELOPE CANAN is Assistant Professor of Sociology at the University of Denver. Her research combines sociology of community with law and politics and has focused on local political issues of land use, community services, and public utilities. She is currently coprincipal investigator with Professor Pring on an NSF-sponsored study of litigation over constitutionally protected citizen participation in governance. She is vice president-elect of the Society for Applied Sociology.

SHELDON EKLAND-OLSON is coauthor of *Texas Prisons* (Austin: Texas Monthly Press, 1987). He is an Associate Professor of Sociology at the University of Texas, Austin. He is currently working on an historical study of death penalty practices in Texas as well as an analysis of systemwide adjustments to prison crowding.

She has published articles on how people attribute responsibility and determine sanction as well as on how children are taught to adhere to norms. She is currently comparing socialization practices and children's normative judgments in elementary schools in Japan and the United States. JOHN P. HEINZ is Distinguished Research Fellow at the American Bar Foundation and Professor of Law and Sociology at Northwestern University. He is the coauthor of *Chicago Lawyers: The Social Structure of the Bar* (1982), and has long specialized in research on political elites, including lawyers.

DONALD D. LANDON is Professor and Head of the Department of Sociology, Anthropology, and Social Work at Southwest Missouri State University, Springfield. His doctoral work was done at the University of Kansas. In 1982–83 he was a Visiting Scholar at the American Bar Foundation in Chicago, where he was project director for the nonurban bar study.

EDWARD O. LAUMANN is Professor of Sociology and Dean of Social Sciences at the University of Chicago. He has written numerous articles and books on social stratification, elites, and networks of collective action, including most recently a book on organizational networks involved in national policies on health and energy. He currently is a principal investigator in a study of patterns of sexual behavior in American society.
