R. Gerald Hughes is a lecturer in the Department of International Politics at Aberystwyth University, an associate fellow of the Centre for Intelligence and International Security Studies and reviews editor for the journal *Intelligence and National Security*. His recent publications include *Britain, Germany and the Cold War: The Search for a European Détente 1949–1967* (2007); *Intelligence, Crises and Security: Prospects and Retrospects* (edited with Len Scott, 2008); and *Exploring Intelligence Archives: Enquiries into the Secret State* (edited with Len Scott and Peter Jackson, 2008).

Talbot Imlay is an associate professor of history at the Université Laval, Québec. He is the author of *Facing the Second World War: Strategy, Politics and Economics in Britain and France 1939–1940* (2003). He is currently writing a book on socialist internationalism, which focuses on the efforts of British, French and German socialists to co-operate on international issues during the twentieth century, as well as co-writing a book with Martin Horn on the experiences of US businesses in France during the Second World War.

Carl Levy is a Reader in European Politics in the Department of Politics, Goldsmiths, University of London. He specialises in the history and politics of Italy since 1860, the history and ideology of fascism, anarchism and syndicalism, the history of ideas, comparative European politics and the government, governance and politics of the European Union. He has written six edited and single-authored books. He is currently finishing a volume on Antonio Gramsci, and is also writing a biography of Errico Malatesta.

Rachel J. Owen is a research assistant in the Department of International Politics, Aberystwyth University. She was awarded a Ph.D. in November 2006 for a thesis entitled 'The Olympic Games and the Issue of Recognition: British and American Perspectives, 1944–1972'. A modified version of it is to be published as part of the Harvard Cold War Studies series.

David D. Roberts is Albert Berry Saye Professor Emeritus of History at the University of Georgia. His most recent books are *The Totalitarian Experiment in Twentieth-Century Europe: Understanding the Poverty of Great Politics* (2006) and *Historicism and*

Fascism in Modern Italy (2007). While continuing to study fascism, totalitarianism and historicism, he is working on a book treating selected artistic responses to the chain of defining, often cataclysmic, events in Europe from the First World War to the fall of communism.

Julius Ruiz is a lecturer in the School of History, Classics and Archaeology at the University of Edinburgh. He is author of *Franco's Justice: The Repression in Madrid after the Spanish Civil War* (2005), and is currently writing a monograph on the Republican repression in Madrid during the civil war.

Bernard Rulof is an assistant professor in European Studies at the Department of History, University of Maastricht. In 2007 he published a monograph on political mass rallies organised by the Dutch social democratic party during the interwar years, entitled *Een leger van priesters voor een heilige zaak. SDAP, politieke manifestaties en massapolitiek, 1918–1940*. In addition, he has written articles about French nineteenth-century royalism, soon to be published by *Cultural and Social History* and *French History*.

Dietmar Süß is Dilthey-Fellow in Modern History at the Friedrich-Schiller-University, Jena. He has produced a range of books and articles about German social and cultural history in the twentieth century, and his book *Kumpel und Genossen. Arbeiterschaft, Betrieb und Sozialdemokratie in der bayerischen Montanindustrie 1945–1976* (2003) was awarded the Leibniz Dissertation Prize. He is co-editor (with Winfried Süß) of *Das 'Dritte Reich' – Eine Einführung* (2008) and co-editor (with Jörg Arnold and Malte Thiessen) of *Luftkrieg. Erinnerungen in Deutschland und Europa* (2009).

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor John Connelly, jfconnel@berkeley.edu.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

- Contributors of accepted papers should send a final version via email. This should include
1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
 2. a 100-word summary of the article in English, French or German
 3. a short title for use as a running page-head
 4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
 5. a short description of work in progress and previously published work
