The JOURNAL is the official organ of the Association for Symbolic Logic, an international organization for furthering research in symbolic logic and exchange of ideas among mathematicians, philosophers, and others interested in this field.

Individual membership in the Association is open to anyone interested in its work. Annual dues for members are \$40, or \$20 for students. Dues include subscription to the current volume of the JOURNAL. For their personal use, members may purchase back volumes at a discount. The JOURNAL invites submission of (1) original technical papers in the field of symbolic logic, (2) expository papers in this field, (3) papers whose main point is philosophical and which either bear upon logic or make use of its methods, and (4) studies in the history of logic in which modern technical developments are taken into account.
