Weed Science is the official publication of the Weed Science Society of America, 113 N. Neil St., Champaign, IL 61820. It is published bi-monthly, one volume per year, six issues per year beginning in January.

Membership is \$20 per year, student affiliate membership \$10, which includes receipt of the *Weed Science*, *Weeds Today*, and WSSA Newsletter. Dues should be sent to WSSA, 113 N. Neil St., Champaign, IL 61820 not later than December 1 of each year. Membership in the society is on a calendar year basis only.

Subscriptions (institutions, libraries, etc.) are \$25 per year, one volume per year of six issues beginning January. New subscriptions and renewals begin with the first issue of the current volume and should be sent to WSSA, 113 N. Neil St., Champaign, IL 61820.

Change of address affecting the mailing list for members, students, and subscribers, inquiries about copies lost in the mail, requests for back issues, and all matters pertaining to the receipt of the Journal, membership, and subscription information should be sent to WSSA, 113 N. Neil St., Champaign, IL 61820. Claims for copies lost in the mails must be received within 30 days (90 days foreign) of the date of issue to insure replacement at no charge.

Manuscripts must be sent to the office of the Managing Editor located in the Department of Botany and Microbiology, Auburn University, Auburn, AL 36830. Directions for contributors are published annually in the January issue of *Weed Science*.

Publication page charge, approved by the officers and directors of WSSA, is \$45 per printed page for material published. Payment of this charge is not a condition for acceptance of a paper. To defray the charge to authors who are members of the society, an application for exemption should accompany the return of the galley proof stating that they are unable to pay the charge and that the institution or organization with which they are affiliated is also unable to honor the request for payment of this charge. Under such conditions consideration will be given for exemption.
