Through a richly detailed historical investigation of the peasant agriculture of *ancien-régime* France, the author uncovers evidence that requires a new understanding of what constituted economic growth in such societies.

Hoffman discovers that growth cannot be explained by culture, property rights, or farm size, and argues that the real causes of growth derived from politics and gains from trade.
