International NETWORK

The International Network for Social Network Analysis, which was founded in 1977 by Barry Wellman, Associate Professor of Sociology, University of Toronto, is interested in drawing its organization to the attention of political scientists. The 200-member group of social scientists from all continents is interested in social network analysis. The principal activity of INSNA is its thrice-yearly informal journal, *Connections*, which provides a variety of infor-

mation: review articles, although not substantive research papers, preliminary news of research findings, computer programs, theoretical and methodological developments, new books, unpublished and published papers abstracts, an annotated updated directory of members and their interests, thesis summaries and conference information. Recent issues have been about 60 pages. INSNA has also sponsored and co-sponsored a number of conferences, including a recent World Congress at Uppsala, Sweden. Among the research that INSNA members do which may be of interest to political scientists is the analysis of interlocking corporate directorships and structural studies of political contentions for power.

WOMEN in Government Forum

In March, 1978, the Department of Public Administration at The George Washington University added a new feature to its community services program: The Forum on Women in Government. Sensitive to the concerns of a growing number of women pursuing careers in public service, the Forum was created to provide a setting for scholarly, professional, and personal exchange among men and women.

Meeting monthly, the agenda highlights a prominent guest speaker. Topics are wide-ranging, encompassing issues pertinent to professional women such as recognizing and dealing with sex discrimination, the current status and future picture for women entering politics, balancing career and family, and reinterpreting what power means to and for women. PARLIAMENTARY Intern Program

The Department of Politics of Catholic University in cooperation with Educational Programmes Abroad is offering upper level and graduate students an opportunity to work full-time as Research Assistants to members of Parliament for a ten-week period during the coming summer from May 16 to July 27.

The Internship involves a close relationship with the Member of Parliament since that institution provides little in way of administrative support. It may comport a broad range of duties in addition to research, including constituency relations, representation, party liaison, etc. Parliamentary sponsors for Interns are matched on the basis of background, interests and ideological orientation.

Six semester hours of credit are given for this Internship. Candidates are selected from the Mid-Atlantic region on the basis of interests, previous academic performance, personality and evidence of maturity. A written biographic summary (including questions on interests and professional objectives), an oral interview and a test of written expression are normally employed to screen applicants.

Prospective Interns are advised to read extensively in British government and politics, and are given supplemental materials directly relevant to their work as Research Assistants. Interns provide their own transportation to London and back; the Laker Skytrain or a charter are advised. Intensive briefings, assignment of lodgings and a basic familiarization with British life begin on Wednesday, May 16, at West Dean, a Conference Center near Chichester. The following Monday Interns begin work at Westminster. Lectures, tours and special programs focused on British government complement the Interns' professional activities. They are expected to maintain a log indicating their activities and the time spent on them day by day. They are also asked to retain any non-confidential studies they prepare. These materials, the M.P.-sponsor's assessment and a departmental oral examination based on the Intern's reading and experience provide the basis for grading. The oral review and examination is in the Fall.

Enrollment fee for the Parliamentary Internship Program is \$1,300, which covers tuition, housing, breakfast and dinner during the period of the Internship. A \$200 deposit, refundable prior to March 31, 1979, is required upon acceptance into the Program, and the remainder is due on May 15, 1979.

GLOBAL Political Assessment

Global Political Assessment, a semi-annual analysis of global political, economic and military trends is published every six months. It analyzes events and trends affecting the industrial democracies, the global economy, the global military situation, the north-south dialogue, east-west relations and the communist countries. It provides a survey of trends in each region of the world.

Global Political Assessment was founded in 1976 by Zbigniew Brzezinski and William H. Overholt, to provide a concise but comprehensive survey of world trends for use by senior foreign affairs executives and business planners. As the only regularly available survey of global trends, it has begun to be used by scholars for research purposes and by teachers as the most concise available introduction to world affairs.

APQ CONGRESSIONAL Elections Issue

Since manuscripts will be subjected to the normal refereeing process, early submissions are advisable. AEI CONGRESS Study

The American Enterprise Institute for Public Policy Research has initiated a new project for the study of the Congress. The project will conduct sustained scholarly investigation into the Congress as an institution. It will cover its formal rules, informal norms, party structure, staffs, internal distributions of power and the recruitment and composition of its membership. Co-directors of the project are John Bibby of the University of Wisconsin, Milwaukee, and AEI Adjunct Scholar, and Thomas E. Mann of the American Political Science Association who will be an AEI visiting fellow. The work of the project will include a biennial congressional review analyzing important institutional and membership changes; analyses of major changes in Congress over the past two decades; their consequences and prospects for the future, and monographs on congressional process, politics and policy. Political Power and Ideology SEMINAR

For the two years 1980-82 the subject of the Seminar of the Shelby Cullom Davis Center for Historical Studies at Princeton University will be the relationship between political power and ideology. The seminar hopes to deal with topics involving the ways in which political systems in

the past have gained or lost legitimacy. These will include the history of use made of ideas of the state, power, and legitimacy; the manipulation of education, religion, ritual, and other cultural forms to support or weaken the political status quo and to obtain or limit participation and consent; and the reasons why such methods have succeeded or failed. The seminar proposes to examine these general problems through historical case studies of particular state systems and systems of ideas.

The Center will offer a limited number of Research Fellowships for one or two semesters, running from September to January and from February to June, designed for highly recommended younger scholars, as well as for senior scholars with established reputations. Candidates who have not both finished their dissertations and had at least a year of full-time teaching experience thereafter are not eligible. Fellows are expected to live in Princeton in order to take an active part in the intellectual interchange with other members of the Seminar. Funds are very limited, and candidates are, therefore, strongly urged to apply to other grant-giving institutions as well as the Center.

SCHOLAR-DIPLOMAT Program

The Scholar-Diplomat Seminar Program will begin its tenth year this fall. University faculty members spend a week in the State Department observing the foreign policy process at first-hand and discussing current policy issues. The Seminars bring together scholars, particularly younger Ph.D.s and government officers involved in making and executing foreign policy. More than 1500 scholars have participated in the program since its inception in 1969. One indication of the program's effectiveness is the fact that most new applications are received from scholars who have heard about the program from previous attendees.

To facilitate informal give-and-take discussion, the seminars are kept small (20 is the usual maximum). A key element of the program is the assigning of each scholar to a host officer whose interest most nearly matches that of the scholar. During the week the scholar views the host officer's work, discusses policy papers and contributes knowledge and ideas. Participating scholars receive a security clearance prior to the Seminar and are therefore able to read classified materials and discuss fully their host's work.

As part of the Seminar, workshops are scheduled "for scholars only" during which candid, unbiased observations are drawn together by participants for a paper that is usually presented to the host bureau's assistant secretary and/or country directors. In some cases the paper is forwarded to the Secretary of State.

In-depth sessions are arranged with the major organizational units of the Department, both geographic and functional. Similar sessions are also arranged with other government agencies involved in the foreign policy process.

ington Summer Institute in Quantitative Political Research. The courses for the Institute will be taught from Monday, June 11 to Saturday, July 14.

The Institute offers introductory courses for both undergraduate and graduate credit in the practical application of statistical techniques to the study of politics in such areas as public policy evaluation, international and comparative politics and the study of public opinion.

The courses are taught by faculty members from the participating universities and practitioners in the Washington area and are held on the Georgetown campus. A weekly seminar session allows participants in the Institute to meet with people working in the field and discuss aspects of the practical problems and uses of quantitative approaches.

Each course is offered for three credits. The tuition is \$345 per course.

The four courses to be taught are Introduction to Quantitative Political Analyses, Quantitative Analysis of Comparative and International Politics, Quantitative Analysis and Evaluation of Public Policy and Survey Research Techniques. The *Political Science Thesaurus* was created to provide a "terminology-regulating" device for a computer-based information storage and retrieval system being designed at the University Center for International Studies, University of Pittsburgh, in conjunction with the American Political Science Association. This information system is now in published form and known as *United States Political Science Documents*.

The *Political Science Thesaurus* comprises, in addition to a foreword and a preface, a *Description and Use of the Thesaurus* section, the *Thesaurus of Terms*, a *Permuted Index*, a *Hierarchical Index*, and three *Appendices—Thesaurus Rules and Conventions, Sources of Terms Used* in the Data Bank, and a list of *Participants* in the production and creation of the *Thesaurus*. The main body of the publication—the *Thesaurus of Terms*—consists of *Part I: Political Science Terminology* and *Part II: Geographical/Political Areas*.

The *Political Science Thesaurus* is available in both casebound and paperback editions of 470 pages. The paperback is \$15.00 to individuals and \$25.00 to institutions.
