EDITORIAL POLICY

The *British Journal of Political Science* is an independent journal, whose policy is set by its editorial board. It is committed to no methodological orthodoxy over and above the normal canons of scholarship: clear and consistent use of words, logical and mathematical validity, and the use of appropriate evidence to substantiate empirical statements. Contributions are invited in all fields of political science. Work addressed to problems of general significance to students of politics will be published whatever the period(s) or place(s) drawn upon for evidence.

SUBSCRIPTIONS

British Journal of Political Science (ISSN 0007-1234) is published quarterly in January, April, July and October. Four parts form a volume. The 1995 subscription price (excluding VAT) of a volume (which includes postage) is £42 (US \$84 in USA, Canada and Mexico) for individuals ordering direct from the publishers and certifying that the Journal is for their personal use; for institutions it is £83 net (US \$152 in USA, Canada and Mexico).
