Tudor England abounded with traitors great and small, whose ill-timed, self-defeating, and irrational antics guaranteed their failure. From the inept and calamitous activities of “Sweet-Lips” Gregory Botolf in 1540 and Lord Admiral Thomas Seymour under Edward VI to the bungling efforts at a palace coup by Robert Devereux, second Earl of Essex, during the final years of Elizabeth’s reign, treason never succeeded. The contemporary explanation was ironically brutal: “If it prospers, none dare call it treason.” Modern historians tend to dismiss this plethora of political disasters and seemingly idiotic machinations as the work of men of unsound mind—unlikely characters from a bad historical novel—or as the fabrications of a frightened and desperate government. Lacey Baldwin Smith re-evaluates the Tudor mania for conspiracy in the light of psychological and social impulses peculiar to the age.

**Prison Reform in Lancashire,
1700-1850**
A Study in Local Administration

Margaret DeLacy. Like many reforms of the modern period, prison reform has evoked prolonged controversy. This work asserts that despite the continuing debate and the many books on prison reform, we actually know very little about what was being reformed. Focusing on the county of Lancashire, this is a detailed history of the conditions of local prison life and administration during the era in which the modern prison was created. The author follows Lancashire's prison system over a 150-year period in order to determine what the system was like before reform and to relate the details of Lancashire's evolving prison system to larger issues. Thus, the reader is able to evaluate the day-to-day workings of the system against the more general history of the rise of prisons and penal theory. 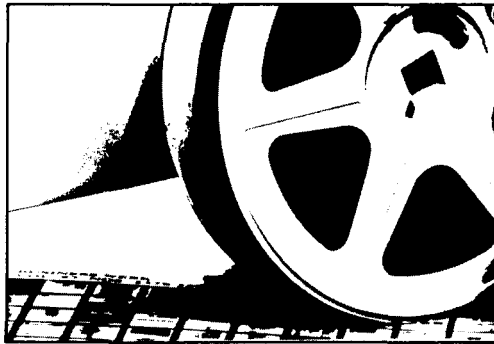
