
The Peasant Economy and Social Change in North China

Philip C. C. Huang. The author integrates three major traditions of peasant studies and uses vast quantities of new materials to present a convincing interpretation of the origins and nature of the agrarian crisis that gripped the North China Plain in the two centuries before the Revolution. Through a comparison of the histories of small family farms and larger scale managerial farms, the author documents and illustrates the long-term trends of agricultural commercialization, social differentiation, and mounting population pressure. He shows how those changes combined to produce, within the small peasant economy, a noncapitalizing managerial elite and a partially proletarianized peasantry, a pattern of change different from and more volatile than the development in Western Europe of a capitalizing elite and a proletarianizing peasantry. \$37.50


The Potosí Mita, 1573-1700 *Compulsory Indian Labor in the Andes*

Jeffrey A. Cole. Potosí was for over a century the most important source of silver in the Spanish American Empire. It owed much of its success to the mita, a system of draft Indian labor for working the mines and refineries. Assailed as a form of servitude worse than slavery and accused of depopulating the provinces subject to it, the mita was supported, however reluctantly, by many who believed that Potosí silver was essential for Spain's survival. This book traces the evolution of the mita through the end of the Hapsburg epoch, focusing on its metamorphosis under pressures of changing production at Potosí and demographic developments in the provinces. It also considers the factors that hindered the Hapsburg government's effective administration of the mita. \$29.50
