NOTES ON CONTRIBUTORS

J. B. BULLEN is Professor of English at the University of Reading. He has had a long-standing interest in interdisciplinary studies and his books include *The Expressive Eye: Vision and Perception in the Work of Thomas Hardy* (Oxford, 1986) and *The Pre-Raphaelite Body: Fear and Desire in Painting, Poetry and Criticism* (Oxford, 1998). His most recent book is a history of the Byzantine Revival entitled *Byzantium Rediscovered* (London, 2003).

ALEX BREMNER has recently completed his Ph.D. on the imperial architecture of nineteenth-century London at Cambridge University where he was a Gates scholar. He received the Society's essay medal in 2002 and is currently undertaking a post-doctoral fellowship at the Paul Mellon Centre for Studies in British Art, Yale University, where he is preparing a study on ecclesiology and the colonial church.

DAPHNE FORD joined the Department of the Environment's Directorate of Ancient Monuments and Historic Buildings in 1969, where preparation for *The History of the King's Works* was then underway. Between 1973 and 1996 she worked at Hampton Court Palace, producing the Hampton Court Brick Typology in 1991.

ANTHONY GERAGHTY is writing a catalogue of the Wren drawings archive at All Souls College, Oxford. He teaches art history at the University of York.

QINGHUA GUO studied architecture at the Department of Architecture, Harbin University of Technology, China, and received her Ph.D. in architectural history at the Chalmers University of Technology, Sweden. She was a researcher at the Kyoto University, Japan, before commencing at the University of Melbourne as Lecturer in Asian Architecture. Her publications include *A Visual Dictionary of Chinese Architecture* (Melbourne, 2002) and *The Structure of Chinese Timber Architecture* (London, 1999).

MICHAEL HALL is the editor of *Apollo*. He is the author of a history of Waddesdon Manor (2002) and has edited a volume of essays, *Gothic Architecture and Its Meanings 1550–1830* (2002). He is currently completing a book on Bodley and Garner.

TANIS HINCHCLIFFE is Senior Lecturer in the History and Theory of Architecture at the University of Westminster. She is the author of *North Oxford*.

CHRISTINE JACKSON is Staff Tutor in History at the Department for Continuing Education, and Fellow of Kellogg College, at the University of Oxford. Her publications include *Newbury Workhouse Records 1627–1641*.

NEIL JACKSON is the Hoffman Wood Professor of Architectural Engineering at the University of Leeds. Equally interested in the nineteenth and twentieth centuries, his book on the California modernist Craig Ellwood (Laurence King Publishing, 2002) won the 49th Sir Banister Fletcher Award.

FIONA LESLIE joined the V&A in 1990, where she worked in the Department of Sculpture, and most recently as Assistant Curator in the Designs Section of the Word & Image Department. Her publications include *Designs for 20th Century Interiors* (V&A, 2000) and *Contemporary Rugs: art and design* (Merrell, 2002)

LINDA MONCKTON is a Senior Architectural Investigator for English Heritage, where she has worked since 2003. Before that she worked for the Cathedrals Fabric Commission for England for six years. She studied at Warwick University where she gained her Ph.D., on Late Gothic Architecture in South West England, in 1999; since then she has published on late medieval architecture and chantry chapels.

STEPHEN OLIVER trained as an architect at Cambridge University and is Senior Architect at Rodney Melville & Partners, specializing in works to historic buildings. Whilst he is a member of the Art Workers' Guild and the SPAB, and has worked in East Anglia, he is not related to Basil Oliver.

HANNAH LE ROUX lectures at the University of the Witwatersrand in Johannesburg. She is interested in the modern architecture in Africa, particularly since the 1950s, and is working on a book on tropical architecture in Ghana and Nigeria.

JOHN W. STAMPER is an architect and architectural historian who received his Ph.D. from Northwestern University. He is the author of *Chicago's North Michigan Avenue: Planning and Development, 1900–1930*, and is currently the Associate Dean of the University of Notre Dame School of Architecture.

MICHAEL TURNER read geography and archaeology at Exeter University, where he completed a Ph.D. on urban renewal after fires in pre-modern England. He joined English Heritage in 1985 and is now an Inspector of Ancient Monuments and Historic Buildings within the Government Historic Estates Unit, which includes responsibility for advising on Hampton Court.
