

EDITORIAL POLICY: The *Nordic Journal of Linguistics* is the journal of the *Nordic Association of Linguists*. The journal is primarily devoted to the publication of contributions from the members of the Association, but contributions from non-members may be submitted to the Editorial Board for consideration. The *Nordic Journal of Linguistics* is concerned with all branches of linguistics. Preference is given to contributions of general theoretical or methodological interest and to studies on Scandinavian languages (including Finnish and Saami). In addition to original articles the journal will publish replies and comments on articles published in the journal and review articles or brief reviews of current books. The Journal will be published in two issues annually, forming together one volume of approximately 200 pages.
