CELIA APPLGATE is William R. Kenan, Jr. Professor of History at Vanderbilt University (Department of History, 2301 Vanderbilt Place, PMB 351802, Nashville TN 37235; email: celia.applegate@vanderbilt.edu). She is the author of numerous books and essays on German nationalism and the cultural history of music, including *The Necessity of Music: Variations on a German Theme* (2017), and *Bach in Berlin: Nation and Culture in Mendelssohn's Revival of the St. Matthew Passion* (2010; winner of the DAAD/GSA Book Prize). With her coauthor of the article in this issue, Pamela Potter, she coedited *Music and German National Identity* (2002).

SHELLEY BARANOWSKI is distinguished professor of history emerita at the University of Akron, Ohio (Department of History, University of Akron, Arts and Sciences 216, Akron, OH 44325–1902; email: sbarano@uakron.edu). Her publications include *Nazi Empire: German Colonialism and Imperialism from Bismarck to Hitler* (2011); *Strength through Joy: Consumerism and Mass Tourism in the Third Reich* (2004); *The Sanctity of Rural Life: Nobility, Protestantism, and Nazism in Weimar Prussia* (1995); *The Confessing Church, Conservative Elites, and the Nazi State* (1986).

KENNETH D. BARKIN is professor of history emeritus at University of California, Riverside (1212 HMNSS Building, 900 University Ave., Riverside, CA 92521; email: kenneth.barkin@ucr.edu), and served as editor of *Central European History* from 1991 to 2004. The author of *The Controversy over German Industrialization, 1890–1902* (1970), Barkin published thirty-five articles on Germany; two of these won the biannual prize of the Conference Group for Central European History for best article in the field. His most recent work examined the experiences of W. E. B. DuBois in Germany.

DORIS L. BERGEN is the Chancellor Rose and Ray Wolfe Professor of Holocaust Studies in the Department of History and Anne Tanenbaum Centre for Jewish Studies at the University of Toronto (100 St. George Street, Room 2074, Toronto, ON, Canada, M5S 3G3; email: doris.bergen@utoronto.ca). Her research focuses on religion, gender, and ethnicity in the Holocaust and World War II. Bergen is the author, editor, or coeditor of five books, including *War and Genocide: A Concise History of the Holocaust* (3rd ed., 2016); *Alltag im Holocaust: Jüdisches Leben im großdeutschen Reich 1941–1945* (coedited with Andrea Löw and Anna Hájková, 2013); *Twisted Cross: The German Christian Movement in the Third Reich* (1996). She is currently completing a book on military chaplains in Nazi Germany.

CHAD BRYANT is an associate professor of history at the University of North Carolina at Chapel Hill (Department of History, CB# 3195, Hamilton Hall, UNC-CH, Chapel Hill, NC 27514; email: bryantc@email.unc.edu). He is the author of *Prague in Black: Nazi Rule and Czech Nationalism* (2007) and has edited two volumes with global themes: *Borderlands in World History, 1700–1914* (with Cynthia Radding and Paul Readman, 2014), and *Walking Histories*,

1800–1914 (with Arthur Burns and Paul Readman, 2016). His current book project, “Prague: Belonging and the Modern City,” is a study of national imaginations and urban experiences in Prague from the early nineteenth century to the present.

ROGER CHICKERING is professor emeritus of history at Georgetown University and holds a courtesy appointment at the University of Oregon (7718 SW Surfland St., South Beach, OR 97366; email: chickerr@georgetown.edu). His publications include *Imperial Germany and a World Without War* (1975); *We Men Who Feel Most German* (1984); *Karl Lamprecht* (1993); *Imperial Germany and the Great War, 1914–1918* (1998); and *The Great War and Urban Life in Germany: Freiburg, 1914–1918* (2007). A revised edition of his biography of Karl Lamprecht will appear in German in 2019.

JOHN DEAK is the Carl E. Koch Associate Professor of History at the University of Notre Dame (219 O’Shaughnessy Hall, Notre Dame, IN 46556, USA; email: jdeak@nd.edu). He is the author of *Forging a Multinational State: State Building in Imperial Austria from the Enlightenment to the First World War* (2015). His current research deals with the collapse of the Habsburg Empire during World War I. The first fruits of that project include an article he coauthored with Jonathan E. Gumz: “How to Break a State: The Habsburg Monarchy’s Internal War, 1914–1918,” which appeared in the *American Historical Review* in 2017.

MATTHEW P. FITZPATRICK is an associate professor in international history at Flinders University (College of Humanities, Arts and Social Sciences, GPO Box 2100, Adelaide 5001, South Australia, Australia; email: matthew.fitzpatrick@flinders.edu.au). He is the author of *Purging the Empire: Mass Expulsions in Germany, 1871–1914* (2015) and *Liberal Imperialism in Germany: Expansionism and Nationalism, 1848–1884* (2008). He has been a Humboldt Fellow at the University of Münster and is currently working on a monograph on Kaiser Wilhelm II’s role in German foreign and colonial policy prior to World War I.

MICHAEL GEYER is Samuel N. Harper Professor Emeritus in the Department of History at the University of Chicago (Department of History, 1126 East 59th Street, Chicago, IL 60637; email: mgeyer@uchicago.edu). He has edited, with Adam Tooze, *Total War: Economy, Society, Culture at War*, which is the third volume of *The Cambridge History of the Second World War* (2015); and, with Helmuth Lethen and Lutz Musner, *Zeitalter der Gewalt: Zur Geopolitik und Psychopolitik des Ersten Weltkrieges* (2015). He is currently completing a study, together with Charles Bright, on the global condition in the long twentieth century, as well as a collective biography: “Die Bratus: A Minor History of Twentieth-Century Germany.”

KES GISPEN is professor emeritus of history at the University of Mississippi (Croft Institute for International Studies, P.O. Box 1848, University, MS 38677; email: gispem@olemiss.edu). He is the author of *New Profession, Old Order: Engineers and German Society 1815–1914* (1989) and *Poems in Steel: National Socialism and the Politics of Inventing from Weimar to Bonn* (2001), as well as of articles and book chapters on intellectual property law and the social history of engineers in Germany.

WILLIAM GLENN GRAY is an associate professor of history at Purdue University (University Hall, 672 Oval Drive, West Lafayette, IN 47907; email: wggray@purdue.edu). His publications include *Germany's Cold War: The Global Campaign to Isolate East Germany, 1949–1969* (2003), as well as articles in *Diplomatic History*, *German Politics & Society*, *International History Review*, and *Vierteljahrshefte für Zeitgeschichte*. He has also published numerous essays in edited volumes. Gray is nearing completion of “Trading Power,” a reevaluation of German foreign relations from Konrad Adenauer to Helmut Schmidt. In 2015 he was awarded the DAAD/AICGS Prize for Distinguished Scholarship in German and European Studies.

KAREN HAGEMANN is the James G. Kenan Distinguished Professor of History and adjunct professor of the Curriculum in Peace, War, and Defense at the University of North Carolina at Chapel Hill (Department of History, Hamilton Hall, CB # 3195, Chapel Hill, NC 27599–3195; e-mail: hagemann@unc.edu). She has published widely in modern German, European, and transatlantic history, the history of military and war, and gender history. Her most recent monograph, *Revisiting Prussia's Wars Against Napoleon: History, Culture and Memory* (2015), won the Hans Rosenberg Prize for the best book in Central European history in 2016. She is currently preparing a monograph titled *Forgotten Soldiers: Women, the Military, and War in Modern History*.

DONNA HARSCH is a professor of history at Carnegie Mellon University (Department of History, CMU, Pittsburgh, PA 15213; email: dh44@andrew.cmu.edu). She is the author of *Revenge of the Domestic: Women, the Family, and Communism in the German Democratic Republic, 1945–1970* (2007) and *German Social Democracy and the Rise of Nazism, 1928–1933* (1993). Her most recent article, “Translating Smoke Signals: West German Medicine and Tobacco Research, 1950–1970,” appeared in the journal *Social History of Medicine* in 2015. She is working on a book-length comparative study of infant mortality and efforts to reduce it in the German Democratic Republic and the Federal Republic of Germany from 1945 to 1990.

KONRAD H. JARAUSCH is Lurcy Professor of European Civilization at the University of North Carolina in Chapel Hill, as well as Senior Fellow of the Zentrum für Zeithistorische Forschung in Potsdam, Germany (Department of History, Hamilton Hall, CB # 3195, Chapel Hill, NC 27599–3195; e-mail: jarausch@email.unc.edu). He has mentored more than four dozen doctoral students on both sides of the Atlantic, and has written or edited some fifty books on German and European history in the nineteenth and twentieth centuries. His most recent book is *Out of Ashes: A New History of Europe in the Twentieth Century* (2015), and his next book, *Broken Lives: How Ordinary Germans Experienced the Twentieth Century*, will appear in the spring of 2018.

JÜRGEN KOCKA is professor emeritus at the Free University of Berlin, where he taught from 1988 to 2009 (WZB Berlin Social Science Center, Reichpietschufer 50, 10785 Berlin, Germany; email: kocka@wzb.eu). He has published widely on the social, economic, and cultural history of Germany and Europe, as well as on comparative history since the eighteenth century. The recipient of many distinguished prizes, including the International Holberg Memorial Prize, Kocka

has published widely in English; this includes *Industrial Culture and Bourgeois Society: Business, Labor, and Bureaucracy in Modern Germany* (1999); *Civil Society and Dictatorship in Modern German History* (2010); and *Capitalism: A Short History* (2016).

SANDRINE KOTT is a professor of modern European history at the University of Geneva (Département d'histoire, 5 rue Saint Ours, 1211 Geneva, Switzerland; email: sandrine.kott@unige.ch). She has published widely on the social history of nineteenth-century Germany, the German Democratic Republic, and, more recently, Nazism. Her first monograph on the German Social State has been entirely revised for a German edition: *Sozialstaat und Gesellschaft. Das deutsche Kaiserreich in Europa* (2014). Her French monograph on the GDR was published in translation as *Day to Day Communism: State Enterprises in East German Society* (2014). Using the archives of various international organizations, she is currently exploring competing social and economic modernities in Europe during the Cold War.

KENNETH F. LEDFORD is associate professor of history and law at Case Western Reserve University (Department of History, 11201 Euclid Avenue, Cleveland, OH 44106–7107; email: kenneth.ledford@case.edu), and served as editor of *Central European History* from 2004 to 2014. He is the author of *From General Estate to Special Interest: German Lawyers 1878–1933* (1996) and of numerous articles. His current research looks at Prussian judges between 1848 and 1914.

CHARLES S. MAIER is the Leverett Saltonstall Professor of History at Harvard University (Center for European Studies, 27 Kirkland Street, Cambridge, MA 02138; email: csmaier@fas.harvard.edu). In addition to numerous scholarly articles and edited volumes, he has published the following books: *Once within Borders: Territories of Power, Wealth, and Belonging since 1500* (2016); *Leviathan 2.0: Inventing Modern Statehood* (2014); *Among Empires: American Ascendancy and its Predecessors* (2006); *Dissolution: The Crisis of Communism and the End of East Germany* (1997); *The Unmasterable Past: History, Holocaust, and German National Identity* (1988); *In Search of Stability: Explorations in Historical Political Economy* (1987); *Recasting Bourgeois Europe: Stabilization in France, Germany, and Italy in the Decade after World War I* (1975).

JAMES VAN HORN MELTON is a professor of history at Emory University (Department of History, 221 Bowden Hall, 561 South Kilgo Circle, Atlanta, GA, 30322; email: jmelt01@emory.edu). His most recent book, *Religion, Community, and Slavery* (2015), was awarded the Austrian Studies Book Prize in 2016. His current project, “The Imperial Lives of Lorenzo Da Ponte,” grew out of a long-standing interest in Mozart and his cultural world. The book examines the careers of Da Ponte, Mozart’s librettist and collaborator, as they unfolded across the imperial metropolises of Venice, Vienna, London, and New York. Melton served as president of the Central European History Society in 2012–2013.

MICHAEL MENG is associate professor of history at Clemson University (Department of History, 120 Hardin Hall, Clemson, SC 29634; email: mmeng@clemson.edu). He is the author of *Shattered Spaces: Encountering Jewish Ruins in Postwar Germany and Poland* (2011), as well as coeditor of *Jewish Space in Contemporary Poland* (2015) and *Modern Germany in Transatlantic Perspective* (2017).

PAMELA M. POTTER is professor of German and music at the University of Wisconsin–Madison (Department of German, Nordic, and Slavic, University of Wisconsin, 868 Van Hise Hall, Madison, WI 53706; email: pmpotter@wisc.edu). Her research concentrates on relating music, the arts, and the writing of cultural history to ideological, political, social, and economic conditions in twentieth-century Germany. She is the author of *Most German of the Arts: Musicology and Society from the Weimar Republic to the End of Hitler's Reich* (1998) and *Art of Suppression: Confronting the Nazi Past in Histories of the Visual and Performing Arts* (2016); she coedited with Celia Applegate *Music and German National Identity* (2002). Current projects include an edited collection of essays on music and World War II, and a book on musical life in Berlin from the Wilhelmine era to the building of the Berlin Wall.

HELMUT PUFF is professor of history and German at the University of Michigan in Ann Arbor (Department of History, 1029 Tisch Hall, 435 S. State, Ann Arbor, MI 48109; email: puffh@umich.edu). He is the author of *Sodomy in Reformation Germany and Switzerland, 1400–1600* (2003) and *Miniature Monuments: Modeling German History* (2014). He has published on the histories of sexuality and gender, the Reformation, and the text-image nexus in early modern culture. Puff is currently working on a history of waiting between 1200 and 1800 as a particular form of experienced time.

MARK ROSEMAN is Distinguished Professor, Pat M. Glazer Chair in Jewish Studies, and professor of history at Indiana University (Department of History, Ballantine Hall 742, 1020 East Kirkwood Ave, Bloomington, IN 47405–7103; email: marrosem@indiana.edu). He is the author of numerous works on the Holocaust and on modern German history. His books include *Jewish Responses to Persecution, 1933–1946: Volume I, 1933–1938* (with Jürgen Matthäus); *The Villa, the Lake, the Meeting: The Wannsee Conference and the 'Final Solution'*; and *The Past in Hiding*. The volume *Beyond the Racial State: Rethinking Nazi Germany*, coedited with Devin Pendas and Richard Wetzell, appeared in 2017. Roseman's work has been translated into fifteen languages.

JAMES J. SHEEHAN is Dickason Professor in the humanities and professor of history emeritus at Stanford University (Department of History, Stanford University, Stanford, CA 94305–2024; email: sheehan@stanford.edu). He has written numerous books and articles on European history, including “What is German History? Reflections on the Role of the Nation in German History and Historiography,” *Journal of Modern History* (1981); he recently coedited, with Andreas Daum and Hartmut Lehmann, *The Second Generation: Émigrés from Nazi Germany as Historians* (2015).

JULIA TORRIE is professor of history at St. Thomas University (History Department, 51 Dineen Drive, Fredericton, NB, E3B 5G3, Canada; email: jtorrie@stu.ca), and serves as associate editor of *Central European History*, responsible for book reviews. Her research focuses on the social and cultural history of Germany and France, and her first book, *“For Their Own Good”*: *Civilian Evacuations in Germany and France, 1939–1945* (2010), compared civilian evacuations in the two countries. She has written articles on soldier tourism, photography, and wartime food history, and is completing a book that uses soldiers’ diaries, letters, and amateur photographs to write a grass-roots history of the German occupation of France.

JOACHIM WHALEY is professor of German History and Thought at the University of Cambridge, and a Fellow of the British Academy (Gonville and Caius College, Cambridge CB2 1TA, United Kingdom; email: jw10005@cam.ac.uk). He is the author of *Germany and the Holy Roman Empire, 1493–1806*, 2 vols. (2012); and *The Holy Roman Empire: A Very Short Introduction* (2018).

GEORGE S. WILLIAMSON is associate professor of history at Florida State University (Department of History, Florida State University, Tallahassee, FL 32306–2200; email: gwilliamson@fsu.edu). He is the author of *The Longing for Myth in Germany: Religion and Aesthetic Culture from Romanticism to Nietzsche* (2004). His article “What Killed August von Kotzebue? The Temptations of Virtue and the Political Theology of German Nationalism, 1789–1819,” which appeared in the *Journal of Modern History* in 2000, won the Hans Rosenberg Prize of the Central European History Society. He is currently completing a book titled “August von Kotzebue: A Political History, 1789–1819.”

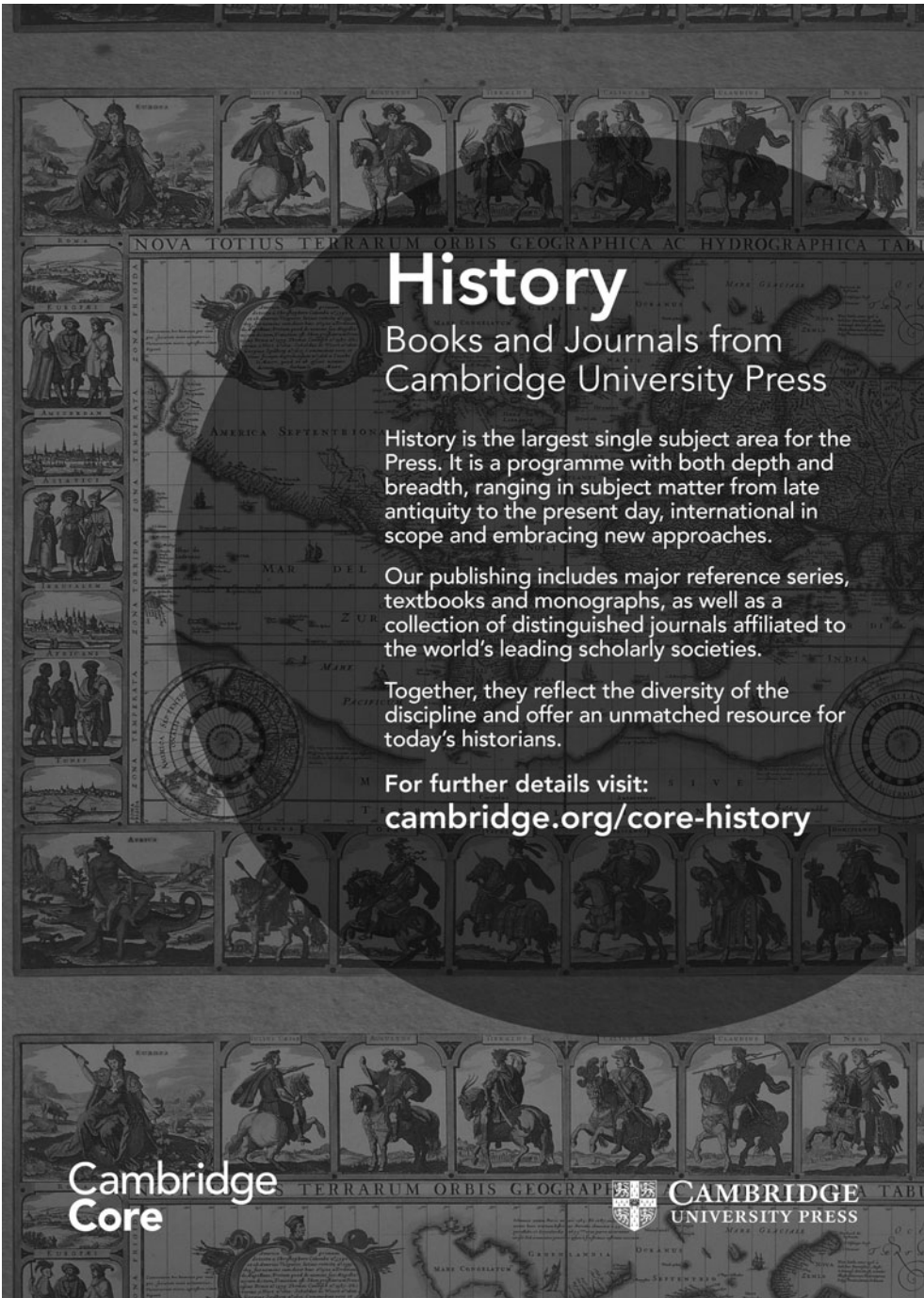

Central European History publishes articles, review essays, and book reviews that range widely through the history of Germany, Austria, and other German-speaking regions of Central Europe from the medieval era to the present. All topics and approaches to history are welcome: cultural, social, political, diplomatic, intellectual, economic, and military history, as well as historiography and methodology. Contributions that treat new fields, such as post-1945 and post-1989 history, maturing fields such as gender history, and less-represented fields such as medieval history and the history of the Habsburg lands are especially desired. The journal thus aims to be the primary venue for scholarly exchange and debate among scholars of the history of Central Europe. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.

The editor prefers that manuscripts be submitted via ScholarOne (<https://mc.manuscriptcentral.com/ccc>). Please take care to remove author identifying information, following the prompts in ScholarOne, to make your manuscript anonymous. The entire text of all manuscripts, including endnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Endnotes must be numbered consecutively and should be placed in a separate section at the end of the text.
