Style A full set of notes for contributors is available from the editors. If possible, this should be obtained before the submission of a manuscript.

The following important points should be noted:

(a) Notes should as far as possible be avoided; they should not contain special symbols such as those used in the International Phonetic Alphabet. They will appear as endnotes rather than as footnotes.

(b) Phonetic transcriptions should, wherever possible, make use of the symbols and conventions of the International Phonetic Alphabet, and should be no 'narrower' than is absolutely necessary for the purpose.

(c) Bibliographical references at the end of each article should conform to the following models:

(d) All copy must be double-spaced throughout, and margins of at least 1½ inches should be left on all four sides of each sheet.

(e) All illustrative material must be numbered consecutively. Tables, charts, and diagrams (though not simple rules or examples) must appear on a separate sheet, in camera-ready form. They should be no more than 1½ times the expected final size.

(f) Typescripts of articles should be submitted in three copies.

(g) No part of a title or section heading should be underlined.

(h) The typescript of an article should be accompanied by an abstract of about 100 words summarising the conceptual content of the article; it should be typed (double-spaced) on a separate sheet of paper.

Proofs First proofs only will be sent to the author (or his nominee), who will be expected to correct them and return them to the editors within three days of receipt.

Offprints 25 offprints and a copy of the volume will be supplied to each author.
