## INSTITUTE NOTES

Lent term begins on Tuesday, January 11th, 1927

The following letter, inviting the co-operation of members in the realization of a scheme for the enlargement of the membership of the Institute and the improvement of its financial position, was issued by the Executive Committee of the Council in November:---

## DEAR SIR OR MADAM,-

We have now entered upon the second session of the Institute's activities, and the following scheme is submitted as of special interest to members.

The first year's record, both in response to the lecture courses and in the reception given to the Institute's Journal, is certainly encouraging. Moreover, the steady growth in membership since the Institute's inception has fully justified the belief of its founders that an increasing number of thoughtful people, both at home and abroad, would welcome contact with an organization devoted to the advancement of Philosophy and its application to the problems of modern life.

In order, however, that the Institute may at an early date become self-supporting, it is essential that the existing membership should be doubled.

It will be remembered that last year it was arranged that those desiring to become members could join the Institute by paying Ios. only as their first subscription for the broken period of the year. It has been decided that for the remainder of the present financial year the same terms shall apply. All members elected after October 15th and before March 31st next will be asked to pay a first subscription of Ios. only. After April 1st, 1927, the subscription will be  $\pounds I$  Is. per annum.

To enlist the co-operation of the present members of the Institute in the work of enlarging the existing membership, a member of the Council, who wishes to remain anonymous, has undertaken to contribute to the funds of the Institute an equal amount (i.e. ios.) in respect of every new member elected in the period between October 15th, 1926, and March 31st, 1927—not exceeding a total contribution of  $\pounds$ 1,000 in respect of 2,000 new members.

The Executive Committee feels that this generous and practicable proposal for placing the finances of the Institute on a minimum satisfactory basis should be accepted. It desires, however, to maintain the high prestige of the Institute, and to exercise as heretofore careful discrimination in the election of members.

The Committee considers that the best way to give effect to the proposal is to invite the active co-operation of existing members. Seeing that there are now nearly 1,500 members on the Register of the Institute, the desired enlargement of the roll would be achieved if each member introduced one or two others for election before March 31st next. The Institute would then be in possession of an income approximate to its minimum expenditure of  $\pounds_{3,000}$  to  $\pounds_{3,500}$  per annum.
