### Committee on Institutional Cooperation Minority Student Fellowship Program

---

The Committee on Institutional Cooperation has received nearly \$800,000 from the Lilly Endowment, Inc. for a program of minority student fellowships for graduate work in the social sciences.

The grant of \$794,534 will fund 50 two-year fellowships for minority group students seeking a Ph.D. in any of seven social science disciplines. The first 25 fellowships will be awarded in April, 1978 for the fall term. Another 25 will be awarded in 1979.

The Committee on Institutional Cooperation (CIC) is a consortium of 11 Midwestern universities—the Big Ten schools plus the University of Chicago. Recipients of the fellowships may use the award at any of the CIC universities, provided they are accepted for admission for graduate study.

Each fellowship will provide a student with a stipend of \$4,000 plus tuition for each of two academic years. Two additional years of financial support will be provided by the doctoral candidate's institution as long as normal progress towards the Ph.D. is being made.

Anyone who has or will receive a bachelor's degree by September, 1978 is eligible to apply for this year's awards. Graduate students who will receive a master's degree by September are also eligible.

The deadline for application is March 1, 1978. A simplified application procedure will combine application for the fellowship with application for graduate study in some of the CIC universities.

The purpose of the fellowship program is to increase the representation of minority group members among those holding doctorates in the social sciences. The fellowships are available to students of anthropology, economics, geography, history, political science, psychology, and sociology.
