in merit order, although in the case of applications deemed to be of essentially equal merit, such additional factors as institutional, geographical, and disciplinary distribution will be considered. Selections will be made without regard to race, color, religion, sex, age, or national origin. Employees of ACDA or relatives of employees are not eligible for this program.

The Hubert H. Humphrey Fellowships in Arms Control and Disarmament will normally be awarded for a period of 12 months. Each Fellow will receive a stipend of \$3,900. No dependency allowances will be paid. No applicant will be eligible for more than one Hubert H. Humphrey Fellowship, although in exceptional cases extensions of up to three additional months may be granted (prorated at \$325 per month). In addition, ACDA will pay any applicable tuition and fees for one year (up to a maximum of \$3,400) to the institution in which the Fellowship winner is enrolled.

Each Fellow will be required to submit to ACDA quarterly progress reports which must be approved by the dissertation adviser, a copy of the final dissertation as approved by the academic institution, and a 5- to 10-page summary of the dissertation's principal findings.

Potential applicants should note that ACDA-supported research dealing with foreign relations or with foreign areas and peoples must be approved in advance by the Department of State if the project involves foreign travel or contact with foreign nationals. Obtaining this permission may involve some delay in initiation of the award.

Fellows will not have access to classified information or conduct research on ACDA premises. Consequently, they will not be processed by ACDA for a security clearance nor will any existing security clearance they may hold be accepted as a basis for allowing access to classified information in connection with this program.

The following schedule applies for the first two competitions for Hubert H. Humphrey Fellowships in Arms Control and Disarmament. Awards for the period January 1, 1979-December 31, 1979: application deadline, July 1, 1978; announcement of final selection, October 1, 1978. Awards for the period September 1, 1979-August 31, 1980: application deadline, March 1, 1979; announcement of final selection, June 1, 1979. Note: Applications will not be accepted before June 1, 1978.
