An all-day workshop conference examining current controversies in law and medicine. This year's first annual conference will focus on the issues of informed consent, do not resuscitate orders, and abortion for minors. The morning session will feature 2 presentations from persons with opposing viewpoints on each of these critical topics. In the afternoon, there will be three concurrent workshops, one on each of the topics. These will be followed by a brief report from each workshop to the entire group which will close the session.

The program will be co-sponsored by ASLM and the Boston University Center for Law and Health Sciences, with Dr. Elliot L. Sagall and Professor George J. Annas acting as co-chairmen of the conference.

It is planned that subject matter include the extent of the problem, significant new developments since the last 1962 AHA Committee Report, the medical and legal evaluation of the relationship between stress and heart disease, workers' compensation and heart disease, cause-and-effect relationships involving stress and heart disease and disability evaluation of the cardiac patient.
