THE PHYLLIS GOODHART GORDAN BOOK PRIZE

THE RENAISSANCE SOCIETY OF AMERICA has instituted an annual book prize of \$1,000, in memory of the late Phyllis Goodhart Gordan, a strong supporter of the RSA from its early days. The purpose of the prize is to recognize significant accomplishment in Renaissance Studies by members of the RSA and to encourage Renaissance scholarship.

The first Gordan Prize will be awarded to the author of the best book in Renaissance Studies published between July 1, 1994, and June 30, 1995. Authors of book submissions must be current members of RSA. The winner will be announced at the annual national meeting at Bloomington, Indiana, April 18-21, 1996.

The prize will be awarded to a book written in one of the disciplines recognized by the RSA. Please see the inside cover of the bi-annual Directory of Members of the RSA for the list of disciplines. The prize will be awarded for a book dealing with a Renaissance topic within the chronological period, 1300-1700. The following are offered as examples of Renaissance topics: a vernacular or neo-Latin literary author, topic, or text; humanism in any of its forms; printing; a Renaissance city-state and/or its institutions; the art or an artist of the period. These topics are not meant to exclude other possibilities. Bibliographical works and scholarly aids are eligible for the Gordan prize, but editions of texts and translations will not be considered. The book must be written in English.

Books will be judged on the following criteria:

- A. Contribution to Renaissance studies
- B. Originality in insight and research
- C. Clarity and eloquence
- D. Thoroughness and accuracy in documentation.

One copy of each work, together with a brief curriculum vitae, must be received by each of the following prize committee members. Each entry should be labeled "Gordan Prize Entry." Entries must be postmarked by or on July 15, 1995, to be eligible. Late entries will not be considered.







In this wide-ranging volume, Heiko Oberman traces threads of continuity flowing to and through the Reformation. Many of his most important studies appear here in English for the first time.

Professor Oberman explores "experiential" mysticism; the tradition of humility; the "battle on two fronts" waged by the Wittenberg circle against Prierias and Eck; Luther's medieval and apocalyptic conception of *reformatio* and its purpose; the pre-history of "confessionalization" in the Confession of Augsburg and its *Confutatio* by Luther's Roman opponents; Zwingli's plan for a Godly alliance in the southern Germanic ecumene, and the destructive tensions between Zwingli and Luther. In the final chapter he describes a model of three long-term "Reformations" that can also be seen as revolutions: the Conciliar Reformation, the City Reformation, and the Calvinist Reformation of the Refugees.

The often denied and generally misunderstood "continuities" between theological directions of the later Middle Ages, the theological reformation of the early sixteenth century, and subsequent developments are constantly illuminated through exacting detail and compelling insights.
