Celso Thomas Castilho is an Assistant Professor of History at Vanderbilt University. His book *Slave Emancipation and Transformations in Brazilian Political Citizenship* (Pittsburgh, 2016) was awarded the Bolton-Johnson and Warren Dean prizes from the Conference on Latin American History, and the Roberto Reis Prize from the Brazilian Studies Association. His international collaborations include a volume co-organized in Brazil called *Tornando-se livre: agentes históricos e lutas sociais no processo da abolição* (EDUSP, 2015), and a special issue co-edited for *Historia Mexicana* titled “Los ecos atlánticos de las aboliciones hispanoamericanas,” which is due out in 2019. His current book project is an intellectual history of slavery, focused on the circulation of *Uncle Tom’s Cabin* in Latin America.

Zephyr Frank is the Gildred Professor of Latin American Studies at Stanford University, where he teaches in the Department of History. He most recent work is *Reading Rio de Janeiro: Literature and Society in the Nineteenth Century* (2016).

Glen Goodman is an Assistant Professor of Brazilian Studies at the University of Illinois at Urbana-Champaign. His work has appeared in *German History*, *Global Food History*, and *Review: Literature and Art of the Americas*, among other publications. He is completing his book manuscript, *Indelible Whiteness? Race, Nation, and German Ethnicity in Brazil*, a study of how changing understandings of German-Brazilian identity complemented and complicated visions of Brazilian nationhood in the 19th and 20th centuries.

James P. Woodard is a Professor of History at Montclair State University. He is the author of *A Place in Politics: São Paulo, Brazil, From Seigneurial Republicanism to Regionalist Revolt* (2009), as well as articles published in the *Hispanic American Historical Review*, *International History Review*, *Journal of Latin American Studies*, *Journal of World History*, and *Luso-Brazilian Review*. He recently completed a book-length study of the history of US-style consumerism in twentieth-century Brazil.

Aaron Coy Moulton is an Assistant Professor of Latin American History at Stephen F Austin State University. His research has been supported by the

Truman Library Institute, the Roosevelt Institute, the Eisenhower Foundation, the Marine Corps Heritage Foundation, the Society for Historians of American Foreign Relations, the American Philosophical Society, the Bentley Historical Library, the Massachusetts Historical Society, and Phi Alpha Theta. His article “Building Their Own Cold War in Their Own Backyard: The Transnational, International Conflicts in the Greater Caribbean Basin, 1944–1954” in *Cold War History* (2015) won the Sturgis Leavitt Award for Best Article from the Southeastern Council of Latin American Studies. His current manuscript, *Caribbean Blood Pact: The Global Cold War against the Guatemalan Revolution, 1944–1954*, reveals how Guatemalan exiles, Caribbean Basin regimes, transnational corporations, and the British government set into motion a global counter-revolution against the Guatemalan Revolution that became the foundation of the U.S. government and the Central Intelligence Agency’s infamous 1953–1954 Operation PBSUCCESS.

Benjamín N. Narváez is Assistant Professor of History at the University of Minnesota, Morris. His research focuses on Chinese migration to Latin America during the nineteenth and twentieth centuries. He has recently published articles in the *Journal of Social History* and the *Asian Journal of Latin American Studies*.

Alexander Sotelo Eastman is a Postdoctoral Fellow with the Society of Fellows at Dartmouth College where he teaches and researches the African Diaspora in Latin America and the Caribbean. He has published articles on the black press, abolitionism, and the history of tourism in the Americas in journals such as *Afro-Hispanic Review*, *Bulletin of Spanish Studies*, *Siglo diecinueve*, and *Studies in Latin American Popular Culture*. He is the editor of *The Critical Surf Studies Reader* (Duke University Press, 2017), an interdisciplinary volume about the history and development of surfing as indigenous practice, subcultural movement, and neoliberal industry. He is currently finishing a book manuscript, *Binding Freedom: Cuba’s Black Press in the Era of Colorblindness*, which maps a history of black intellectual thought during Cuba’s abolitionist and civil rights movements.
