Alexander Rosenberg is Professor of Philosophy and Director of the Honors Program at the University of Georgia. In addition to coauthoring *Hume and the Problem of Causation* (1981), he has written four books in the philosophy of social science, particularly economics, and three books on the philosophy of biology, focusing primarily on the relationship between molecular genetics and functional biology. He has received fellowships from the Guggenheim Foundation, the National Science Foundation, and the American Council of Learned Societies, and in 1993 he was awarded the Lakatos Prize in the Philosophy of Science for *Economics—Mathematical Politics or Science of Diminishing Returns?* (1992). His most recent book is *Instrumental Biology, or The Disunity of Science* (1994). In 1994-95, he taught philosophy at Oxford University.

Allen Buchanan is Grainger Professor of Business Ethics and Professor of Philosophy and Medical Ethics at the University of Wisconsin, Madison. He has written numerous articles in ethics, epistemology, political philosophy, bioethics, and other areas of applied ethics, and is the author of *Marx and Justice: The Radical Critique of Liberalism* (1982), *Ethics, Efficiency, and the Market* (1985), *Deciding for Others: The Ethics of Surrogate Decision Making* (with Dan W. Brock, 1989), and *Secession: The Morality of Political Divorce from Fort Sumter to Lithuania and Quebec* (1991).

H. Tristram Engelhardt, Jr. is Professor in the Department of Medicine, Baylor College of Medicine, and in the Department of Philosophy, Rice University. A member of the Center for Medical Ethics and Health Policy, he serves as editor of the *Journal of Medicine and Philosophy* and coeditor of *Christian Bioethics: Non-Ecumenical Studies in Medical Morality*. He is also coeditor of the book series "Philosophy and Medicine: Philosophical Studies in Contemporary Culture," published by Kluwer Academic Publishers, and of the series "Clinical Medical Ethics," published by Georgetown University Press. His most recent volume is a second edition of his book *The Foundations of Bioethics* (1996).

Eric T. Juengst is Associate Professor of Biomedical Ethics at the Case Western Reserve University School of Medicine. He received his Ph.D. in philosophy from Georgetown University in 1985 and has taught at the medical schools of Penn State University and the University of California at San Francisco. From 1990 to 1994, he was Chief of the Ethical, Legal, and Social Implications Branch of the National Center for Human Genome Research at the U.S. National Institutes of Health.

Henry I. Miller is Robert Wesson Fellow of Scientific Philosophy and Public Policy at the Hoover Institution, Stanford University, and Consulting Professor at Stanford's Institute for International Studies. He graduated from the Massachusetts Institute of Technology with a B.S. degree in life sciences and attended the University of California, San Diego, receiving the M.S. and M.D. degrees. After completing his clinical training in internal medicine at the Beth Israel Hospital in Boston, Dr. Miller spent three years as a Research Associate at the National Institutes of Health. He joined the Food and Drug Administration in 1979 and served in a number of posts involved with the new biotechnology, including Special Assistant to the Commissioner and, from 1989 to 1993, founding director of the FDA's Office of Biotechnology. His research focuses on a variety of public policy issues related to science and technology, particularly biotechnology. He is the author of more than 150 publications.

Michele Svatos is Assistant Professor of Philosophy at Iowa State University. Her work is in virtue ethics, bioethics, intellectual property, and philosophy of economics. She is currently working on a book manuscript entitled *The Foundation and Structure of Virtue Ethics*.

Robert P. Merges is Professor of Law at the University of California, Berkeley, School of Law (Boalt Hall). He is the author of numerous articles on the law and economics of intellectual property, as well as the leading law school casebook on patent law. He has testified before Congress many times on intellectual property matters. Among other professional activities, he serves as a special consultant to the Howard Hughes Medical Research Foundation.

Svetozar Pejovich is Professor of Economics at Texas A&M University and Senior Research Fellow at the International Centre for Economic Research, Turin, Italy. He is the author of *Economic Analysis of Institutions and Systems* (1995), *The Economics of Property Rights: Towards a Theory of Comparative Economic Systems* (1990), and *Socialism: Institutional, Philosophical, and Economic Issues* (1987).

R. G. Frey is Professor of Philosophy at Bowling Green State University and Senior Research Fellow of both the Kennedy Institute of Ethics at Georgetown University and the Westminster Institute of Ethics and Public Policy at the University of Western Ontario. He received his D.Phil. from Oxford University in 1970, and has taught at the University of Liverpool, at St. John's College, Oxford University, and at the University of Toronto. He is the author of *Interests and Rights* (1980) and *Rights, Killing, and Suffering: Moral Vegetarianism and Applied Ethics* (1983). In addition, he is the editor of *Utility and Rights* (1985), and the coeditor (with Christopher W. Morris) of *Liability and Responsibility: Essays in Law*

and *Morals* (1991), *Violence, Terrorism, and Justice* (1991), and *Value, Welfare, and Morality* (1993).

David Friedman is Professor of Law at Santa Clara University, specializing in economic analysis of law and computer law. He received a bachelor's degree in chemistry and physics from Harvard University in 1965 and a doctorate in physics from the University of Chicago in 1971. He is the author of two books and many articles, mostly on economics, law, and political theory. He has taught economics at Virginia Polytechnic Institute, the University of California at Los Angeles, the University of California at Irvine, Tulane University, the University of Chicago, and Cornell University.

James H. Fetzer is Professor of Philosophy at the University of Minnesota, Duluth. The author of *Scientific Knowledge* (1981), *Artificial Intelligence: Its Scope and Limits* (1990), *Philosophy and Cognitive Science* (1991), and *Philosophy of Science* (1993), he is the coauthor, editor, or coeditor of twelve other books. In addition, he is the editor of the journal *Minds and Machines*, a coeditor of the journal *Synthese*, and the editor of the series "Studies in Cognitive Systems." He has extensive publications in the philosophy of science, cognitive science, artificial intelligence, and computer science, including more than eighty articles and reviews.

William Bechtel is Professor in the Philosophy-Neuroscience-Psychology Program at Washington University. He works in both the history and philosophy of biology and the conceptual foundations of cognitive science and neuroscience. Currently, he is engaged in a study of the development of cell biology as a scientific discipline in the period from 1945 to 1965. His books include *Connectionism and the Mind* (with Adele Abrahamsen, 1990) and *Discovering Complexity: Decomposition and Localization as Scientific Research Strategies* (with Robert C. Richardson, 1993). He is also the editor of the journal *Philosophical Psychology* and the coeditor, with George Graham, of *The Blackwell Companion to Cognitive Science*.

Susan Haack is Professor of Philosophy at the University of Miami. She was educated at Oxford University and Cambridge University, and has taught at the University of Warwick, U.K. Her books include *Deviant Logic* (1974), *Philosophy of Logics* (1978), and, most recently, *Evidence and Inquiry: Towards Reconstruction in Epistemology* (1993). She has also written numerous articles on philosophy of logic and language, epistemology and metaphysics, pragmatism, and feminism. *Deviant Logic, Fuzzy Logic*, a second, expanded edition of her first book, is scheduled to be published by the University of Chicago Press in 1996. She was president of the C. S. Peirce Society in 1994, and received the University of Miami's award for excellence in teaching during the same year.
