**Honorat Aguessy** is a sociologist, anthropologist, former dean of the Faculté des lettres, arts et sciences humaines at the National University of Benin; he has also worked in the UNESCO Regional Bureau for education in Africa (BREDA). He is President of the Institut de Développement et d'Échanges endogènes (IDEE) in Ouidah, Benin.

**Jean-Godefroy Bidima** was born in 1958 in Mfoumassi, Cameroon. He studied philosophy and sociology at the University of Yaoundé, then philosophy and science of art at the University of Paris I-Panthéon-Sorbonne. He obtained a doctorate in philosophy with a thesis on the Frankfurt School, and holds a degree in the science of art and aesthetics. A former scholarship holder from the Aachen 'Missionswissenschaftliches Institut', Germany, from 1984 to 1990, he was Visiting Associate Professor at the University of Bayreuth, Germany, and is currently programme director at the Collège International de Philosophie in Paris and Associate Professor at the Institut d'Éthique of the university hospital of Saint-Louis in Paris. Among his books are: *Théorie critique et modernité négro-africaine*, *De l'École de Francfort à la 'Doctas pes africana'*, 1993; *La philosophie négro-africaine*, 1995; *L'art négro-africain*, 1997; *La palabre, une juridiction de la parole*, 1997. **Françoise Davoine** was born in Savoie in 1943. She holds the *agrégation* in classical literature, a doctorate in sociology and is a psychoanalyst. A lecturer at the Ecole des Hautes Etudes en Sciences Sociales, in the Centre d'étude des mouvements sociaux (founded by Alain Touraine), she is working on the topic of the relationship of madness to the social bond, based on her clinical experience. For 27 years she was a psychoanalyst in the public psychiatric hospital system and was a member of the Ecole Freudienne de Paris, founded by Jacques Lacan. Since 1995 her work has focused on the madness of war and its consequences for the descendants of ex-servicemen. **Souleymane Bachir Diagne** worked for around 20 years at the University Cheikh Anta Diop in Dakar, teaching in particular logic, history of science and Islamic philosophy. He is now professor of philosophy at Northwestern University, Chicago, and, among other works, is the author of a book on the algebra of logic created by George Boole entitled *Boole, l'oiseau de nuit en plein jour*, 1989; a translation into French of the *Lois de la pensée* by the same author, 1992; and, in the area of Islamic philosophy, an introductory book on the work of the modernist poet-philosopher Iqbal: *Islam et société ouverte, la fidélité et le mouvement dans la pensée de Muhammad Iqbal*, 2001. **Jean-Max Gaudillière** was born in Mâcon in 1943. He was a student at the Ecole Normale Supérieure and gained the *agrégation* in classical literature and a doctorate in sociology. A psychoanalyst, he taught in the French Department at Yale University before becoming a lecturer at the Ecole des Hautes Études en Sciences Sociales, in the Centre d'étude des mouvements sociaux. He was a member of the former Ecole Freudienne de Paris, founded by Jacques Lacan. In connection with his work as an analyst in psychiatric hospitals, he has for 25 years led, with Françoise Davoine, a weekly seminar at the EHESS entitled 'Madness and the social bond'. He is the author of many articles on psychotic transfer; his next publication (with Françoise Davoine) is a book due to be published in the USA, *History beyond Trauma*. **Paulus Gerdes** holds a doctorate in the philosophy of natural science (Dr. phil.) and a doctorate in higher mathematics (Dr. rer. nat. habil.) from the universities of Dresden and Wuppertal (Germany), and has taught in Mozambique at the Universidade Eduardo Mondlane and the Universidade Pedagógica. Between 1989 and 1996 he was vice-chancellor of the Universidade Pedagógica. Currently he is chair of the Commission de l'Union Mathématique Africaine sur l'Histoire des Mathématiques en Afrique (since 1986); chair of the Groupe International d'Etudes sur l'Ethnomathématique (since 2000) and chair of the Association Internationale pour la Diversité Scientifique et Culturelle (since 2001). He was elected member of the Académie Africaine des Sciences en 2002, and is the author of several books published in Brazil, France, Germany, Mozambique, Portugal, Sweden and the USA, some of which have won prizes, for example *Géométrie en Afrique*, 1999, and *Femmes, art et géométrie en Afrique du sud*, 1998. He has also published around 150 research articles.

**Paulin J. Hountondji** teaches philosophy at the University of Cotonou (Benin), and has published in particular *Sur la 'philosophie africaine': critique de l'ethnophilosophie* (Paris, 1977 ; Yaoundé, 1980); *Combats pour le sens: un itinéraire africain*, 1997, and, with collaborators: *Les Savoirs endogènes: pistes pour une recherche*, 1994 ; *Economie et société au Bénin*, 2000. Now Director of the Centre Africain des Hautes Etudes in Porto-Novo, he was vice-president of the CIPSH from 1998 to 2002. Since December 2002 he has been vice-president of the Conseil pour le Développement de la Recherche en Sciences Sociales en Afrique (CODESRIA).

**Ioanna Kuçuradi** was born in 1936. She teaches philosophy and is chair of the philosophy department at Hacettepe University in Ankara, was president of the council for human rights in Turkey (1994–6), and is a member of several international cultural organizations. She has published many articles in international journals, and in 2002 received the Prix de l'Éducation aux Droits de l'Homme (UNESCO). **Richard Rorty** was born in New York in 1931. From his first studies on pragmatism in the early 1960s he became one of the most important representatives of a movement which includes a number of philosophers who are re-examining the assumptions of the tradition they have represented. Having taught philosophy at Princeton and the University of Virginia, he is currently teaching at Stanford University. He is the author of a very large number of books and articles, which have been translated into several languages. Among the best known are: *Philosophy and the Mirror of Nature*, 1979; *Contingency, Irony and Solidarity*, 1989; *Essays on Heidegger and Others: Philosophical Papers*, 1991; *Truth, Politics and 'Post-Modernism'*, 1997; *Achieving Our Country: Leftist Thought in Twentieth Century America*, 1998; *Philosophy and Social Hope*, 2000.
