ANNOUNCEMENT

POLICY ON ILLUSTRATIONS FOR THE JOURNAL

All illustrations submitted to the Journal, both half-tones and line drawings, MUST be at publication size and each mounted upon 8½ × 11 in. (21.5 × 28 cm) WHITE cardboard. Only ORIGINAL prints of half-tone illustrations will be accepted. Those which have been previously screened will not provide acceptable reproduction.

Half-tones mounted as multiple square or rectangular parts of a figure should be butted together along straight lines with figure numbers (NOT LETTERS) affixed on the lower right-hand corners of each part. The printer will create narrow spaces separating the individual figures. Wherever possible, reduce the number of half-tone figures for the manuscript by combining illustrations of different taxa within one figure rather than making separate figures.

Adherence to the above policy will allow safer and more rapid processing of manuscripts and will reduce costs related to the publication of the Journal.
